- Rendering of positions of tables and chairs relative to entrances, exits and sidewalk to be submitted with application
- Site plan drawn to scale showing proper clearance around ingress and egress to buildings and to fire safeguard and proper amount of clearance on sidewalk for pedestrian traffic
- Survey map indicating property lines of private property in question and Village property.

The following must be submitted prior to the issuance of a permit:

- Certificate of Insurance must be submitted as required under Section 285-5 and Hold Harmless Agreement below.
- Fee: \$3.05 per square foot
- Deposit: \$500
