

DRAFT PROPOSED LOCAL LAW

LOCAL LAW INTRO. 1-2010, ENTITLED A  
LOCAL LAW TO AMEND CHAPTER 11-1  
OF THE VILLAGE CODE REGARDING  
FEES FOR RETURNED CHECKS.

BE ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MAMARONECK AS  
FOLLOWS:

SECTION 1.

That Village Code Chapter 11-1 CHECKS, RETURNED, entitled "Imposition of service charge authorized." is deleted in its entirety.

OLD LANGUAGE:

§ 11-1. Imposition of service charge authorized.

In the event that any payment tendered by a check or other written instrument on any account owing to the Village of Mamaroneck is returned for insufficient funds, there is hereby authorized the imposition of a service charge to be added to that account owing to the village in the sum of twenty dollars (\$20.) per check or other written instrument so returned, and the principal of such account shall be increased accordingly.

SECTION 2.

That new language for Village Code Chapter 11-1 CHECKS, RETURNED, entitled "Imposition of service charge authorized." is hereby enacted, as follows:

NEW LANGUAGE:

§ 11-1. Imposition of service charge authorized.

In the event that any payment tendered by a check or other written instrument on any account owing to the Village of Mamaroneck is returned for insufficient funds, there is hereby authorized the imposition of a service charge to be added to that account owing to the village in the amount of the service charge imposed by the bank, in addition to the sum of twenty dollars (\$20) per check or other written instrument so returned for administrative costs incurred by the Village for re-processing such returned check or written instrument, and the principal of such account shall be increased accordingly.

SECTION 3. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with the Municipal Home Rule Law.
