- Disturbance greater than 1,000 sf. Disturbances greater than 1,000 sf require a Stormwater Pollution Prevention Plan (SWPPP), consistent with Chapter 294-8B(sub 1-3)

- **Disturbance between 200sf and 2,000sf require the SWPPP to include erosion and sediment controls and stormwater quality controls.**
- **Disturbances between 2,000sf and one (1) acre requires the SWPPP to include erosion and sediment controls, stormwater quantity controls and stormwater quality controls.**
- **Disturbance in excess of one (1) acre require the applicant to obtain coverage under New York State Department of Environmental Conservation (NYSDEC) SPDES General Permit for Stormwater Discharges from Construction Activities (GP-0-20-001). In addition to a full SWPPP, the applicant shall prepare a draft Notice of Intent (NOI) and the SWPPP MS4 Acceptance Form.**
- **Increase in building coverage or increase in impervious surfaces and anticipated cost of improvements 25% or more of the value of the existing building improvements. Must base pre-development runoff on the unimproved lot area.**
