

Proclamation of Local Emergency

I, Jerry Barberio, Village Manager of the Village of Mamaroneck, acting within the authority granted to me by section 24 of the Executive Law of the State of New York, having found that the Covid-19 pandemic has given rise to a public emergency within the territorial limits of the Village of Mamaroneck, and that the public safety is imperiled thereby, do hereby proclaim a local emergency within the Village of Mamaroneck. This local emergency will continue until it is rescinded by me or until August 27, 2021, whichever is later.

Promulgation of Local Emergency Orders

I, Jerry Barberio, Village Manager of the Village of Mamaroneck, having proclaimed a local emergency within the Village of Mamaroneck, promulgate the following local emergency orders to protect life and property and to bring the emergency situation under control:

1. Pursuant to Executive Law § 24(1)(c) and (e), the following regulations will apply to the premises at 169 Mount Pleasant Avenue:

(a) All persons entering, leaving and present within the Village of Mamaroneck Police Station and Courtroom must comply with the directions of Village of Mamaroneck Police Officers.

(b) The Village of Mamaroneck Justice Court will conduct its proceedings in the Courtroom, but (i) no one other than the parties to the matter then before the Court and their counsel will be permitted in the Courtroom; (ii) other parties will assemble and wait outdoors for their matters to be called; and (iii) no visitors will be allowed in the Courtroom.

(d) Access to Court offices will be limited to Court staff. No visitors will be allowed in the Court office.

(d) Payment of fines for violations may be made only at the first-floor (lobby) payment window.

(e) No one other than Village Building and Planning staff will be permitted in the Building and Planning Offices.

(f) All individuals (staff, patrons, contractors, etc.) must wear face coverings while in the building at 169 Mount Pleasant Avenue unless they are alone in a private office.

2. Pursuant to Executive Law § 24(1)(c) and (e), the following regulations will apply to the premises at 123 Mamaroneck Ave:

(a) All Village employees will operate out of their respective offices.

(b) No one may enter the Clerk-Treasurer's/Building Department Office other than the employees who work within the Clerk-Treasurer's Office/ or are Building Department clerical staff. All transactions with the Clerk-Treasurer's Office and all transactions regarding recreation administrative services and building department functions will be conducted at the vestibule window.

(b) No one may enter the Village Manager's Office, the Village Engineer's Office, the Village Human Resources Office and the Village Public Information Office, except the employees who work, respectively, in those offices. Employees will operate out of their respective offices.

(c) All individuals (staff, patrons, contractors, etc.) must wear face coverings while in the building at 123 Mamaroneck Avenue unless they alone in a private office.

3. Pursuant to Executive Law § 24(1)(c) and (e), the following regulations will apply to the premises at Harbor Island Park Pavilion, the Parks Building and the Harbormaster's Office:

(a) No one other than a Village of Mamaroneck employee may enter the Parks Building or the Harbormaster's Office.

(b) All individuals over the age of 15 (staff, patrons, contractors, etc.) must wear face coverings while in the Harbor Island Pavilion, Parks Building, Marine Education Center, or Harbor Master's office unless they alone in a private office.

4. Pursuant to Executive Law § 24(1)(c) and (e), the following regulations apply to the premises at VMFD Headquarters / Fire Station, 146 Palmer Avenue Mamaroneck, NY 10543; Columbia Fire Station, 605 North Barry Avenue Mamaroneck, NY 10543; Volunteer's Fire Station, 643 Mamaroneck Avenue Mamaroneck, NY 10543; and Halstead Manor Fire Station 1400 Halstead Avenue Mamaroneck, NY 10543:


(a) No person may enter VMFD Headquarters / Fire Station, Columbia Fire Station, Volunteer's Fire Station and Halstead Manor Fire Station other than police, fire, ambulance and other emergency personnel.

(b) All individuals must wear face coverings while at VMFD Headquarters / Fire Station, 146 Palmer Avenue Mamaroneck, NY 10543; Columbia Fire Station, 605 North Barry Avenue Mamaroneck, NY 10543; Volunteer's Fire Station, 643 Mamaroneck Avenue Mamaroneck, NY 10543; and Halstead Manor Fire Station 1400 Halstead Avenue Mamaroneck, NY 10543 office unless they are alone in a private office

5. Nothing in these regulations prohibits emergency responders from entering or remaining within any place in the course of their emergency duties.

6. These regulations will remain in effect for five days after promulgation or upon my declaration that the state of emergency no longer exists, whichever occurs sooner, but may be extended for additional periods not to exceed five days each during the pendency of the local emergency.

7. Pursuant to Executive Law § 24(5), any person who knowingly violates any provision of this local emergency order is guilty of a class B misdemeanor.
