# Village of Mamaroneck Day Camp FAQ - 2024

What dates are camp in operation?

VMDC at Harbor Island Park will operate Monday – Friday. From July 1<sup>st</sup> – August 9<sup>th</sup>. There will be NO camp on Thursday, July 4<sup>th</sup> and Friday, July 5<sup>th</sup>, in observance of the holiday.

# What are the camp hours of operation?

Camp hours of operation are from 9:00am until 3:00pm., Monday – Friday. Early Morning and Extended Day programs are available for the 2024 camp season. Early Morning drop off begins at 7:30am until 9:00am. Extended Day hours are from 3:00pm until 4:30pm. Fees for both programs apply to the entire six-week camp season and are NOT pro-rated for unused days.

# Where will camp be held this year?

Camp activities will be held at Harbor Island Park. Most of the activities will be outdoors. Campers will have access to shade/covered under tents. Only campers in grades 5<sup>th</sup> - 10<sup>th</sup> will be permitted to visit off-site locations.

# What ages does VMDC serve?

VMDC is offered to children 4 years of age (Pre-K) by the start of camp and up to teens entering 10<sup>th</sup> grade in the FALL of 2024.

# Will there be counselors in training?

The CIT program will NOT be offered this year.

# Will there be a limit on the number of campers?

Registration is on a first come first served basis, with priority registration given to residents of the Village of Mamaroneck. *Please bear in mind that registration may close before the non- resident registration period opens.* 

# Will all age groups be together?

The Westchester County Department of Health has no current restrictions on limiting grade interactions. Camp grades may interact during special events and on-site/off-site entertainment.

## Are refunds given?

The Village of Mamaroneck maintains a comprehensive NO refund policy for day camp. This includes any cancellation of camp due to quarantining, excessive inclement weather and/or disciplinary action. In addition, the purchase of insurance offered through CampDoc is in no way connected to your child's registration with the Village of Mamaroneck. The Village of Mamaroneck is not responsible for any reimbursement in the event of a CampDoc insurance claim.

#### Will there be a parent orientation this year?

Yes, parent orientation will be on Zoom and dates are as follows:

- For campers in grades Pre-K 4<sup>th</sup>, orientation will be on Monday, June 3<sup>rd</sup> at 7:00 pm
- For campers in grades 5<sup>th</sup> 10<sup>th</sup>, orientation will be on Tuesday, June 4<sup>th</sup> at 7:00 pm

## Will there be health checks?

No, currently health checks are not required by the Westchester County Department of Health.

#### What are the Drop Off and Pick Up Procedures?

#### Drop-off:

• Parents will drop off campers to their designated grade level spot as mapped out in the parent guide.

#### Pick-up:

• Counselors will bring campers to their designated grade level spots at dismissal time. Older siblings will be brought to younger siblings.

#### Will campers be swimming?

All swimming will take place at Stephen E. Johnson Beach and Splash Pad. Grades 3<sup>rd</sup>- 10<sup>th</sup> will be swimming and grades PK - 2<sup>nd</sup> will use the splash pad. Campers will NOT be swimming at Hommock 's Pool.

## Will there be special events/trips?

Campers in grades PK through 4<sup>th</sup> grade will not be visiting any off-site locations. All activities will be held at Harbor Island Park. Various entertainers will perform on-site. Grades 5<sup>th</sup> – 10<sup>th</sup> will be taking buses to off-site locations.

## Will there be food or snacks provided?

Pizza will be offered every Friday and is a part of the camp tuition. There will be Ice Cream days and a last day of camp BBQ. Ice Pops will also be offered periodically during the camp season. Lunch and other snacks must be provided by campers.

## Will you have sanitizing stations available?

Yes, sanitizing stations will be available throughout the facility.

## Will counselors get training for all new procedures this year?

Yes, counselors are required to complete training in accordance with current Westchester County Department of Health protocols and guidelines.
