**Old Business**

1. Mamaroneck Avenue- Pedestrian's traffic improvements going towards White plains where the curb is, to make that a median strip Jerry will ask the county to look into it. County discussed looks like we are slated to receive \$100,000 grant. Per. Jerry meeting to be setup with Kevin Rosman for October. Dan reported that we did get funding for phase one. Done (Leave on)
2. Walking assessment was done for Fenimore Road and Prospect and Maple and Munro Avenue. Lisa Nelson concerns with going in and out of her driveway. Dan spoke to Matt and said that it was part of the capital project. Did not discussed at July's meeting. (Leave on)
3. Orienta Avenue – 4 Way Stop Discussed Dan to request crash data from chief. Dan will forward to TC when he receives it. Did not Discussed at July's meeting. (Leave on)
4. Walter's Hot Dogs – Crosswalk – Resident Katharine DeCicco attended the meeting and is requesting if they could put back the crosswalk in front of Walter's and the High School on Palmer. When they paved Palmer, they never put it back. Kelly will talk to Jerry to have them put it back. George Latimer stopped by the TC zoom meeting and Kelly asked if he could have the crosswalk put back on Palmer Avenue, connecting the rear of Mamaroneck High School to Walter's hot dog stand. George said he will take care of it. Kelly emailed George Latimer and Cc Catherine Parker. Did not discussed at July's meeting. Kelly sent follow to George Latimer (Leave on)

5. South Barry Avenue and Guion Resident Steve Trifilette attended the meeting with concerns cars speeding down South Barry, resident would like to see a stop sign at the corner of South Barry and Guion Drive. Chief Sandra Driuzza said speed trailer was put back to collect data with the lights off. Discussed at July's meeting. Mini-walking assessment in the spring. (Leave on)
6. Mamaroneck Avenue – Brixmore Shopping Center Intersection – Resident Allison Stabile attended TC meeting with concerns entering and exiting the shopping and making a left onto New Street. David will email Dan to see if when making a left onto New Street the county can add a left turn arrow. Dan will follow up with the county. Did not discussed at July's meeting. (Leave on)
7. N. Barry Avenue and Brook Street Intersection – Stop Sign – Kelly emailed Police Chief for crash data. Chief Sandra DiRuzza said there was negative results from the past 5 years. Resident Tim Grant attended meeting and had concerns with speeding something needs to be done. Dan will contact Chief Sandra DiRuzza. Chief DiRuzza suggested the village to look into a sign with flashing lights. The Board suggested to remove 2 spaces on the right side and left side going down N.Barry and resident Tim Grant will ask residents if they agree. Did not discussed at July's (Leave on)
8. Taylors Lane and Colonial Court – Resident Lindsay Reitzes attended TC meeting with concerns Taylor's Lane, Colonial Ct. and Barrymore speeding in those areas. Kelly emailed Police Chief for crash data. Chief Sandra DiRuzza said there was negative results from the past 5 years. Chief will also attempt to have the speed trailer to Taylors Lane.
