**Parks & Recreation Commission Meeting**

**February 10, 2021**

Meeting was brought to order at 6:30 pm. Attendees were Randi Robinowitz, Kerrie Sergio, Kristen Vetter, Tina Maresca, Dan Margoshes, Carlo Reza, Brittany Ross, Cindy Fasolino, Manny Rollins

We introduced ourselves to Manny Rollins, our newest member, and he told us about himself.

First topic discussed was the proposed dog park. Kerrie told us the committee believes the area by the Mamaroneck Schoolhouse which already has parking is the best location. They believe two runs-one for large dogs and one for smaller dogs would be an effective solution.

Randi made a motion to approved funds for a dog park study. Kerrie seconded. Unanimously approved.

Next was a VOM Summer Camp discussion. There will not be field trips in 2021. It was apparent that staff is needed for any meaningful discussion.

Nora informed us about the upcoming PRC budget meeting on March 3. This is an excellent opportunity to learn about how funds are allocated. We agreed to try to attend this zoom call. Because of this the regular PRC meeting was postponed rescheduled to March 10. This was ultimately cancelled.

Tina, Carlo and our new member Manny Rawlings are all going to participate in the Ad Hoc Committee on Year-Round Recreation.

Finally, there was a discussion about a National Fitness Campaign Court. Nora indicated that grants are available to cities and schools, not towns.

Kristen made a motion to adjourn the meeting, Dan seconded. The meeting was unanimously adjourned at 7:10 pm.
