# Parks & Recreation Commission Meeting November 3, 2021 Via Zoom

Randi called the meeting to order at 7:35.

June 2021 PRC minutes were amended to change field fee usage from per person to per hour. Harbor Island launch parking started on Memorial Day but there was no early morning staffing until July 1. Jason is going to investigate an early morning attendant next year.

Karrie made a motion to approve the minutes as amended. Tina second. The minutes were approved.

There was a public request for food allergy signs. The board unanimously agreed to put up food allergy signs where they make sense.

Turkey Trot has 500 entrants now but is expecting over 1000. 1300 tee shirts have been ordered.

All Christmas merchandise is in house and ready for the December 11 Tree Lighting Social.

Jeff gave a report on the state of Warren Park's remediation from flooding. The Park has by inspected by a third-party company who had deemed it safe. All necessary repair items have been ordered.

Brittany wanted to know when Jefferson Park will be renovated. Jeff said 2023 is most likely.

Technically all parks close at dusk.

Dog Park Committee wants to meet with Jeff again and move this project forward.

Capital projects of interest in the next year are replacing Lanza Field lights and new floors in recreation building.

Tina updated us on the tennis committee.

Kristen suggested that we get the Harbor Master to attend the December 1 PRC meeting. She would like more information on kayak racks and paddle board storage. Jason said he would make that call.

Cindy reported the Harbor Island concert raised \$1,000 for flood victims' relief.

Karrie made a motion to adjourn the meeting. Heather seconded. Meeting was adjourned at 8:40 pm.
