The meeting was called to order at 7:11 pm.

The Committee approved the minutes for the May 2, 2023 meeting.

The members reviewed the Report to the Board of Trustees Prepared by the Budget Advisory Committee Assessment of the Elimination of the Village Justice Court which was drafted by Len Aubrey. Len suggested that the Report and the Memorandum from the Village Court Judges be submitted to the Trustees. Committee members who were comfortable with the Report, discussed some of the significant points, including the Village's annual property tax cap will change, the potential increased costs for the Village as a result of the change, that any increase in Mamaroneck and Rye town taxes will be paid by Village residents who are residents of those towns, that there is a significant difference in the volume of cases processed by the Village Justice compared to that of the Mamaroneck Town Court and that the current Court Judges as Village residents know the Village and it's residents. After the discussion, a motion, duly made and seconded, was approved to send the Report to the Board for consideration at the next work session, that Nora Lucas ask that it be added to the next work session agenda and that Len will make the presentation at the work session.

The Committee also discussed a draft email prepared by Charles Guadagnolo to the Board to request a meeting with the Board and Staff to discuss takeaways from this year's Budget process and the Budget Committee's areas of focus for the upcoming year. After a short discussion, the members agreed to discuss it at our next meeting.

The Committee agreed to change the date of the Committee's August meeting to the 8th to be held in the Courtroom.

The meeting was adjourned at 8pm.

 - D) Quarterly review of Operating and Capital Budget.
 - E) Utilize the Budget Committee's Village webpage to share historical reference documents that the Budget Committee created to share with the public and new/interested Board Members.
