# VILLAGE OF MAMARONECK COMMITTEE FOR THE ENVIRONMENT MINUTES OF FEBRUARY 15, 2022

The meeting was held via Zoom and called to order at 7:05 pm.

#### **General Discussion**

The minutes of the Committee's January 18th, 2022 meeting were approved.

Ellen provided the Committee with an update on the Healthy Clubs organization and the various initiatives they are encouraging local clubs to participate in, including sustainable landscaping, food scrap composting, water bottle refilling stations, electric car charging stations and a move away from single-use plastics.

#### **Healthy Yards**

Elizabeth Poyet who heads the Larchmont Mamaroneck Pollinator Pathways chapter then spoke about the various initiatives that group has been involved in recently and will be undertaking in the near term. Elizabeth noted that her group would be happy to work with the Committee in an advisory role on local projects.

It was noted that the National Environmental Education Foundation (NEEF) 2022 Biodiversity Conservation Grant: Enhancing Pollinator Habitats Letter of Intent was submitted today. Ellen thanked Christi and Katherine for their hard work on this project. The Village will be notified by March 17<sup>th</sup> whether it is a finalist and invited to submit a formal application for this grant.

Ellen noted that Tom Murphy has signed the Mayors' Monarch Pledge. This pledge requires the Village to undertake three actionable items per year to raise awareness about Monarch butterflies.

#### **Community Outreach**

May  $7^{th}$  was set as the date for this spring's Clean & Green event which will run from 9:30-11:30 am. This year, the Committee would like to encourage local businesses to participate. It was suggested the Chamber of Commerce could assist with this outreach.

Ellen suggested the Litter Awareness campaign could use the Clean & Green event as a kick-off. Lou agreed to ask the Village to add garbage cans to areas where litter is collecting including area along the Sheldrake and Mamaroneck Rivers and in public parks.

# Clean Energy Communities/Climate Smart Communities Task Force Update

Ellen noted the next meeting is set for March 1<sup>st</sup> and invited Lou to attend.

#### **Food Scrap Recycling Program**

Ellen noted we are the third municipality in Westchester County to offer curbside pick-up for food scraps to residents, behind Rye and Scarsdale.

#### Goals for 2022

Ellen provided a summary of the Committee's goals for 2022 which were adopted. Allison Stabile, a VoM resident and former CFTE chair has requested that our committee address the need to update the Village's telecom ordinance to cover health issues relating to the use of 5G technology. Ellen suggested forming a subcommittee for this large initiative with any interested CFTE members, as well as community members.

The meeting adjourned at 8:45 pm.
