On August 9, 2000, the Board of Traffic Commissioners sent a letter to the Mayor and Board of Trustees to adopt an amendment to Chapter 326 – Vehicle and Traffic Section 80 making no parking anytime on the south side of Stuart Avenue from So. Barry Avenue to the intersection of Guion Drive and Lawn Terrace (attached Exhibit A)

This request came about during the Mobil gas spillage remediation process where there was parking of remediation trucks on the roadway at the two shed locations.

This remediation process was completed more than ten years ago, and this parking prohibition has not been lifted. The current driveways on this street do not accommodate the zoning for this street's housing as most of the homes are two – three family. The no parking has created a safety issue as cars and tractor trailers speed down this empty street. Allowing parking on the street will likely result in reduced speeds as drivers would have to be more careful (attached Exhibit B)

This has also created a hardship for our family in taking care of my 85-year-old father in-law. Visiting nurse service, the physical therapist and the home health aide have difficulty finding parking. If the service provider parks in front of the house they are issued parking tickets. We have found that most often they will reschedule the appoint to avoid getting a ticket.



I write regarding the lack of a stop sign when exiting the shopping center at 805-807 Mamaroneck Avenue. Whether signs are the responsibility of the owner or the village, I presume the village has some oversight.

At the 807 exit, there are 'No Left Turn' and 'Exit Only' signs, as well as a conspicuous stop line at the edge of the parking lot, just before the sidewalk. Unfortunately, despite the clear field of vision, drivers do not stop.

I frequently walk dogs in that neighborhood, and as such, am aware of pedestrian and vehicle rights of way.

While walking today, having just passed Chipoltle, a car rolled through the stop line and across the sidewalk. This kept me, as well as a bicyclist and two women with strollers standing on either side of the sidewalk for several minutes while the driver looked for an opportunity to turn right. This has happened to me, alone, on numerous occasions.

As the location is so close to an elementary school, it seems all the more important that vehicles have both the white stop line and a stop sign for reinforcement. As a driver, I can say that my eyes are drawn to a red sign more readily than a line in the street.

To Whom It May Concern,

I would like to express a safety concern and a proposal for traffic control on Union Avenue. Please consider the following:

- -Speed bumps placed on Union Avenue between Halstead Ave and Tompkins Ave.
- -A stop sign and pedestrian crosswalks on Union at the Ward Ave and Hinman Place cross streets.
- -An all way stop sign on the corner of Union Ave & Tompkins Ave.

When we first moved here, we quickly became aware that Union Avenue was used as a cut through street to avoid traffic on Boston Post Road and Mamaroneck Avenue. Traffic at that point was sporadic, but fast moving. Shortly after, Mamaroneck flooded due to Hurricane Ida causing the Tompkins Avenue Bridge to be closed. This closure and the repair construction on the corner of Boston Post Road & Mamaroneck Avenue has caused our street to be a main thoroughfare for speeding traffic and has made it unsafe for our street's residents. In addition, the road is filled with divots, patches and unnatural bumps from previous road construction. This causes cars to swerve to avoid these conditions. It is extremely dangerous when traveling at the high speeds that cars are currently moving down our block. Especially when young children are walking down narrow sidewalks and crossing the road.

One of the reasons our family moved to Union Ave was because of the proximity to Mamaroneck Ave, the walk ability of the neighborhood and with the hopes that my children would be able to walk to school everyday. Currently, I am wary of letting them have this independence in fear that a moving vehicle will hit them. Union Avenue is in the process of a turn over and families with young kids are moving in. Please consider the proposed ways to make it a safe block for us to raise our children.
