RE: Village of Mamaroneck – Pedestrian Crossing at Mamaroneck Avenue (County Road #8) & Waverly Avenue

Dear Mr. Roseman:

I am writing to ask that the Westchester County Department of Public Works review the alignment of the crosswalk at the Mamaroneck Avenue (County Road #8) and Waverly Avenue intersection in the Village of Mamaroneck. Specifically, I am requesting that the County consider relocating the crosswalk from the north side of the intersection to the south side.

In 2016, the Village of Mamaroneck conducted a traffic and pedestrian safety study in the adjacent Washingtonville neighborhood. As part of this study, traffic counts were taken. During the AM peak period, 33 vehicles made the right-hand turning movement to travel south on Mamaroneck Avenue while 421 vehicles made the left-hand turning movement to head north – a 1275% increase. During the PM peak, this was slightly less with 41 vehicles making the right-hand turn movement while 325 vehicles made the left-hand turning movement – and increase of approximately 800%.

Given that Metro-North's Mamaroneck Train Station is located in general proximity to this intersection on the east side of Mamaroneck Avenue as well as the fact that pedestrians should not cross the west side of Mamaroneck Avenue at the Mount Pleasant Avenue (County Road #44) intersection, it is believed that the majority of the pedestrian activity is either heading east or south and a crossing on the south side of the intersection would be an improvement to overall pedestrian safety.

I am glad to meet with you in-person either at my office or on-site to review this matter and thank you for your attention. If you have any questions, or require additional information, please contact me.



Describe incident details:

During the week, from about 8:00 am on, Mamaroneck High School students park all day until after 3:00 pm immediately to the east of our driveway at 979 Palmer Avenue.

This prevents my wife seeing oncoming west-traveling cars when she backs out of our driveway to take our two young grandchildren to school.

The cars are in a zone marked as one hour parking from 9:00 am to 7:00 pm.

Up until late July of 2001 the Village also had a sign located about 20 feet to the east of our driveway, prohibiting parking past that sign.

On or around July 25, 2001, a driver lost control of his vehicle, and severed that sign. It was never replaced.

Describe desired outcome:

We respectfully request that the Village replace the parking sign in its former location.

Doing this would give all residents of 979 Palmer, a better line of sight and in cases where we still couldn't see oncoming traffic, allow us to back safely into the street (into the freed up 20' parking space) and then check for oncoming cars using side-view mirror before pulling out.

Enforcement is absolutely part of the problem. Another part of the problem is that our parking laws are not universal to the area. There are sections of Mamaroneck that have resident parking and others that don't, so all that is doing is pushing more and more people to park where there is no resident parking (like my neighborhood). We get to have no parking during the day because of all of the teachers, parents, gardeners, etc. and then at night we have people coming from other areas to park because there are no parking regulations other than no commercial parking and even commercial vehicles will park there until someone calls up to complain - in other words, like Monopoly, it's free parking. I see companies that are nowhere near my area dropping off their workers who have parked on the street all day, it's a free for all. Add to that the illegal apartments (so one 2 family house has 10 cars to park), and that leaves the residents that pay all of the taxes with little to no parking. Take a drive past the Avalon and there is usually nowhere to park because the renters don't want to pay for another spot so they take street parking. At least they live in the area, but it still doesn't help.

I am writing today to raise the issues of Taylor's Lane again.

First off, let me start by thanking you all for addressing the issue of speed by installing a speed monitor back in 2021. While it was there I do believe it lowered the speed but frankly, as soon as it disappeared the issue resumed.

I am emailing today because my daughter fell on the broken asphalt and badly injured her hand while scooting to school on Taylor's Lane today during Rye Neck Walk/Bike/Scoot to School Week.

I let the below issues fall to the side after Ida as I knew that there were neighborhoods that needed the Village's attention much more than ours but I now am back to request that my list below be revisited and the Village begin to fix these issues on what is a major pedestrian/bike route for many of the residents of the Rye Neck area. Please refer to my original letter sent in 2021 and I will update my request here:

Below are my suggestions:

- 1. Paint a bike lane from Taylor's Lane to Colonial Court this is needed so badly as we do not have a sidewalk.
- 2. REMOVE the 30 mph speed limit sign on Taylor's Lane and replace with 25 mph = which is the law.
- 3. Move the 10 mph sign further down before the curve
- 4. Add a crosswalk on PBR and Taylor's this is a major crosswalk for many students traveling on bike/foot to the three campuses in Rye Neck and it is located on an active gas station where vision is obstructed by cars parking on/next to the sidewalk, and from the other direction car cannot see pedestrians on Taylor's Lane.
- 5. Install STOP Signs on Colonial Court and Barrymore Lane.
- 6. Repave the curve of Taylor's Lane near Colonial Court and fill in potholes or repave Taylor's Lane and remove all dangerous gravel/debris in road.

I am going to request that the signage be addressed immediately as they are theoretically very easy fixes.

Please let me know if this can be added to the agenda of the next meeting and if you would like me to attend to speak.

I am also happy to reach out to my community if you need additional comments to support these requests.

Dear Robert,

As per your request I have written down an account of:

- (a) The fatal traffic accident on Palmer Avenue near Walter's Hot Dog Stand from which a young girl died
- (b) The discussion I was a participant in about the removal of the cross walk between the Hot Dog Stand and the stairs to the High School.

FATAL TRAFFIC ACCIDENT - THURSDAY, SEPTEMBER 8, 1988

I was working at Walter's Hot Dogs on this day in the capacity of Manager.

Hearing the sounds of the accident I immediately came up from the cellar where I was working and asked staff what had happened.

A young girl, I believe her first name was Donna, said that she had been serving a woman and two young girls. The woman and one of the girls, having received their Italian Ices, left the second young girl (who was still waiting for her ice) and crossed the street leaving the young girl unsupervised.

Upon receiving her ice, the second young girl ran out into the street to join her sister and the woman, and was hit by a car.

I went outside to see if there was anything I could do. EMS and police were on the scene. I spoke to several eyewitnesses and asked what had happened.

They confirmed the staff person's story and elaborated.

The little girl did not use the cross walk.

She ran out into the street from between parked cars.

Her sibling and the adult were on the other side of Palmer.

A police officer I spoke to said that the car that hit the girl was travelling at the legal speed limit of 30 mph since lowered to 20 mph).

I later learned from a March 26, 1992 Gannett newspaper article that the victim's name was Sybil Neuringer. She was 9 years old. Her mother sued for \$25.75 million. The Village agreed to settle; their maximum exposure being only \$40,000.

CROSSWALK DELIBERATIONS - WEDNESDAY, SEPTEMBER 21, 2005

It was my scheduled day off in my capacity as Manager at Walter's Hot Dogs.

I went to the Stand at 12:00 because government representatives County and Village, were coming to discuss the crosswalk issue.

What happened is that there had a crosswalk leading from the Stand to the bottom of the stairs that climb the hill opposite and serve the High School.

The crosswalk was there in 1987 when I began working at Walter's and I believe for much longer than that.

At some point the Village DPW removed it.

To my recollection, when we inquired why it was removed, the Village told the late Gene Warrington (the owner of the Stand at the time) and myself that County law required that they either get rid of the crosswalk or remove five parking spaces on either side of the road.

This law combined with a similar parking restriction on each side of any driveway would mean we would have virtually no parking. So the Village was doing us a favor by removing the crosswalk.

For about two years Gene went on a crusade to get that crosswalk back.

The Village said it was a County issue and that the County wouldn't budge so finally Gene managed to get Judy Meyers, a then County Legislator to come down and talk to him, and she, arranged to get all the pertinent people together.

When the Village rep reiterated the rationale as being due to County parking law, the County Engineer said it had little to do with the County.

Although it is a County road, the Village decides what it wants to do as far as school zones and crosswalks.

So it is up to the village if they wish to put back a crosswalk. The 100 foot rule is not a law, it is a County recommendation for approaching line of sight.

The Village head of the Traffic Commission says he didn't want to cost us money (from lack of parking) and the State law is that 30' is all that is required.

The idea of flashing lights indicating a school zone is mentioned and the County Engineer says we are allowed to do that (Village matter) but he also says that they are not effective in slowing down cars.

After some more conversation everyone ate some hotdogs and the County officials left.

The Village official explained that if they put in a crosswalk and a person is struck while in the crosswalk, the Village is liable.

If we put in a school zone, no crosswalk, and someone is struck, no liability and that is why he doesn't want a crosswalk.

This is my recollection of the Wednesday meeting, written up on the Friday. I don't have the names of the various participants other than Judy Meyers.

Hope this is of help to you in your deliberations.

Dear Traffic Commission,

April 26, 2023

I hope all is well, and thank you for committing the time to the community.

Now that warmer weather is upon us, I'm writing about a dangerous situation by the entrance of Florence Park (on the Park Ave./English Pl. entrance). I'm reaching out after I just witnessed a girl on a bike nearly get hit by a car at the Park Ave./English Pl. crossing.

At the entrance to Florence Park, cars frequently park directly next to the StopsSign(s) on both Park Ave. and English Pl. This creates a treacherous situation when exiting Florence Park, or attempting to cross the street, as oncoming traffic can't see pedestrians. Children constantly traverse this area given there are two schools within walking distance, and this is an entrance to Florence Park.

I attached photos illustrating how cars park on a daily and nightly basis, but if you're familiar with the area (or if you pay a visit on any decent day), you'll see what I mean. These are just from the last two days, but it's a constant situation.

Under NYS law, parking or standing is not allowed "within 30 feet (10 m) of a traffic light, stop sign or yield sign." In addition to being illegal, the parking creates a treacherous situation for children and adults alike entering/leaving Florence Park.

I'd like to propose two things:

- 1. Increased enforcement by the VMPD to stop cars from illegally parking so closely to the Stop Signs.
- 2. Paint/marking on the curb, or a sign, to raise awareness parking is illegal within 30 feet of a Stop Sign.

I'm open to suggestions/ideas from you all too.

In an ideal world, we'd convert this area to a welcoming entrance to the park and promote pedestrian foot traffic (no other entrances to the park allow parking by the entrance gates).

Hi Mayor & Board and Traffic Committee:

I wanted to raise a query about getting a proper cross walk(s) on Halstead, between N. Barry and the Harrison border.

It is very unsafe for children & adults to cross Halstead and the children that live in "Halstead Manor" cross Halstead on foot/bike several times a day in order to go to & from school. I've now lost count of the number of times my son & I have almost been hit, often by drivers who illegally pass cars stopped at Florence St crosswalk, or cars that are speeding.

Many Halstead Manor neighbors believe an ideal spot would be at Halstead & Edward Place — Edward is the small street that dead ends into Florence Park. It would allow kids to cross and from there head to their respective schools via Florence Park: DW, MS/HS and FEB, all schools would require crossing through the park. While there is not currently sidewalk on Edwards, the traffic is very minimal, since it's a short dead end street. It is worth reviewing.

Halstead crosswalks should have pedestrian activated flashing lights and bold street graphics, like the crosswalks in Rye along the Post Road near the High School and Forest Rd, near Rye Town Park — areas where children are frequently crossing and foot traffic is heavier.

The crosswalk at Florence St has been largely unsuccessful. There is no sidewalk going up Halstead towards the crosswalk and the sign in the middle of the crosswalk has been run over and replaced numerous times. Again, pedestrian activated crossing lights & bold street graphics would help immensely.

For the past several months, we have been engaged in the engineering and designed process for the Halstead Avenue Pedestrian Safety Improvements. As part of that project, we are required to have a public presentation of the project, conceptual approach and receive and respond to public comments. Curb extensions are planned as part of that project which were originally contemplated at Ward Avenue, Beach Avenue, Florence Street, and Fourth Steet.

As far as Edward Place, it was not included. As Ms. Brown notes there are no sidewalks Edwards whereas on Florence, there are sidewalk on both sides of the street for the entire length. I think that once we install curb extensions and proper signage, people will choose to the use the Florence crossing as it will be safer.

I am in full agreement about the flashing pedestrian signals and we have started to deploy them in the Village.

Jefferson Avenue Cul-De-Sac parking issue

recently changed the parking configuration at the cul-de-sac at 1025 Jefferson Avenue. According to some residents, this change was made to accommodate a new homeowner at the cul-de-sac, which resulted in the loss of 4 or 6 available parking spaces. The residents requested that the former parking

configuration at the cul-de-sac be restored to allow more cars to park there.

Discussion: The change in parking configuration may have been requested by the VOM Fire Department.

Action: FD Rep LaRocco will check with the VOM FD to see if the change in parking was required by the FD and

Speed Limit at Harbor Island

Issue: Currently there is no Village Code speed limit at Harbor Island Park. On March 23, 2023, Tina Maresca of

the Parks & Rec Commission requested that the Traffic Commission ("TC") consider recommending that

the Village Code include a speed limit for the park.

Discussion: The TC debated various speed limits.

Action: After considerable discussion, Michael made a motion that a speed limit of between 10-15 MPH at

Harbor Island be added to the Village Code. The actual speed limit will be up to the VOM Police Chief

and the BOT. Ryan seconded the motion. The motion was unanimously approved.

It was also recommended that a speed monitoring device be installed at the park to measure the

average speed of vehicles.

Issue: Renee Melagrano resides at 625 Stuart Avenue. On April 10, 2023, she requested that the former sign at

her property be replaced. See Old Business section.

Discussion: This issue is probably related to the restoration of parking on Stuart Avenue.

Action: Ryan will communicate with Ms. Melagrano.

Speed Limit Sign on Harrison Avenue at Osborne Avenue

Issue: Barbara Brown resides at 1419 Harrison Avenue. On April 5, 2023, she reported that cars line up every

morning and afternoon next to her house to pick up and drop off students. Parents make illegal U-turns every morning to rush their children to school. Cars use Osborne Avenue as a short cut and the middle and high school students cross (walk) at this intersection. She requested that the "30 MPH" sign at 1419 Harrison Avenue be moved towards West Street (going towards Harrison). According to her, this is a

dangerous location.

Discussion: The TC agreed that the "30 MPH Speed Limit" sign should be moved closer to West Street. Tina

suggested installing a "No U-turn" sign. Since Harrison Avenue is a County road, the TC believes that this

situation would be best handled by Westchester County.

Action: David will write to Ms. Brown and recommend that she contact a county official to resolve this issue.

Request for a Crosswalk on Palmer Avenue from the MHS to Walters Hot Dog Stand

Issue: Tina reported that Mamaroneck H.S. requested that a crosswalk be painted on Palmer Avenue from the

steps of the school to Walters.

Discussion: According to Tina, Safe Routes to School will draft a letter to the County and the VOM BOT requesting

the crosswalk. She requested that the TC draft a similar letter.

Action: Ryan will draft the requested letter.

Old Business

Stuart Avenue Parking Issue from S. Barry to intersection of Guion Drive

Issue: On October 1, 2022, several residents on Stuart Avenue requested that parking restrictions imposed on

this street 20 years ago be rescinded. By motion on December 12, 2022, the TC recommended that the parking restrictions be rescinded. On January 22, 2023, the BOT approved rescinding the parking

restrictions. On April 7, 2023, Robert Alfano, who resides on Stuart Avenue, wrote to the TC. He believes

that restoring parking on Stuart Avenue has created safety issues and requested that the parking

restrictions be restored.

Discussion: The TC determined that the parking restriction implemented 20 years ago was based on a serious

environmental issue and was never intended to be permanent. After 20 years it was time to restore

parking to normal use.

Action: Ryan will ask Sally to notify residents on Stuart Avenue that the parking restrictions were rescinded. He

will respond to the resident at 625 Stuart.

Revised Traffic Incident Report Form - Web form for traffic complaints

Issue: Laura revised the Traffic Incident Report Form and recommended that it replace the old form.

Discussion: All members of the TC agreed to accept the Revised Traffic Incident Report. Richard recommended that

access to the form be handicapped-accessible. We need to ensure that the new procedure is in place

before we close this matter.

Action: Leilani will write to the Village Manager and the IT Department and request that the form be on the

VOM website, and that the procedure be implemented ASAP. On 04/14/23, Robert wrote to Sally and Elena and requested the implementation of the new procedures using the revised Traffic Incident Report. Ryan also requested that the VOM notify the TC when the new procedures are in place.

412 N. Barry Avenue – removing a parking space on N. Barry

Issue: Justin Gonlag resides at 412 N. Barry. Mr. Gonlag notified the TC on July 12, 2022, that due to visibility

issues, it was dangerous to exit his driveway. At an earlier meeting, the TC rejected his request to add a side mirror. Mr. Gonlag is now requesting the removal of a parking space next to his driveway. Due to a

heavy backlog of Old Business issues, the TC has been unable to address this issue until now.

Discussion: Mr. Gonlag attended the meeting and repeated all the reasons why it was a safety issue for him to exit

his driveway. Everyone acknowledged that we need to address this issue for Mr. Gonlag because it creates a dangerous situation for him. The TC was reminded that six months ago we had a similar request from a resident at 1511 Mamaroneck Avenue to remove a parking space, which has not been addressed. The TC is trying to establish a standard to be applied as to when it is appropriate to remove

parking spaces in the Village.

Action: Before recommending the removal of a parking space at 412 N. Barry, we need to measure the distance

of the parking area near Mr. Gonlag's driveway. Officer LaRocco explained that once we know the foot

measurement then we can apply the applicable Village code. David was assigned to do the

measurement and he will report back at the next meeting. Richard recommended that we adjourn this

issue to our next meeting, when we can get the measurements and make the appropriate recommendation. All agreed. Ryan will notify Dan about our request to measure the space.

1511 Mamaroneck Avenue – removing a parking space on Mamaroneck Avenue

Issue: Mrs. Jaeger resides at 1511 Mamaroneck Avenue. She notified the TC on April 10, 2022, that due to

visibility issues and the excessive speed of cars on Mamaroneck Avenue, it was dangerous to exit her driveway. She requested the removal of a parking space next to her driveway. Due to a heavy backlog of

Old Business issues, the TC has been unable to address this issue until now.

Discussion: This location was discussed in tandem with 412 N. Barry regarding removing a parking space. The TC is

trying to establish a standard as to when it is appropriate to remove parking spaces in the Village. Tina pointed out that Mamaroneck Avenue is a County road and may require County approval to remove the

parking space.

Action: A decision will be made after we establish a standard for removing parking spaces and resolve the

situation at 412 N. Barry.

Rockland Avenue (Waverly to Rockland Avenue Bridge)

Issue: The safety issue for children walking to and from school at this location has been known for a long time.

As Tina has reported, the Safe Routes to School group has been trying to address this location since

2013. Due to the efforts of the TC, this location is finally getting addressed.

Discussion: Robert reported that on 04/10/23, the VOM BOT approved a proposal from AKRF (Matt Carmody) to

conduct a study along Rockland Avenue between the TOM border at Hickory Grove Drive East and

Palmer Avenue and perform a walking safety assessment with various stakeholders at a cost of \$14,500.

Action: See above.

Traffic Commission Spreadsheet

Issue: Ryan stated that it has been suggested by the Village Manager that the Spreadsheet used by the TC may

create a legal liability for the VOM.

Discussion: Ryan suggested that the TC find a way to use the Spreadsheet that does not expose the VOM to liability.

He believes that the Spreadsheet is a valuable organizational tool for the TC and proposed that the TC continue to utilize it. He stated that the Spreadsheet is a record of what we learn about traffic issues. All members of the TC agreed that the Spreadsheet was essential to resolve traffic and parking issues in the Village. Tina commented that the data on the Spreadsheet is reflective of all the Traffic Commission Minutes. Ryan agreed and added that the information and language in the Spreadsheet echoes data and

recommendations in the Walking Assessments done in previous years and in the current Comp Plan.

Action: The spreadsheet will continue to be utilized by the TC but its availability to the public will be limited.

Ranking/Prioritization of Old Business items on the Spreadsheet

Issue: For more than a year, The TC has been trying to deal with dozens of unresolved Old Business issues. It

was decided that we would rank these issues in order of importance. At a prior meeting, members of

the TC were asked to assign a value to each issue.

Action: Ryan tabulated all the values and arrived at an average score for each issue. Another column has been

added to the Spreadsheet with the priority value assigned to these issues. The TC will address the most

important issues first.

Brixmor Shopping Center

Issue: On December 12, 2022, the TC was informed that that there were pedestrian safety issues at the exit at

the Brixmor Shopping Center next to the Chipotle restaurant. Due to a heavy backlog of Old Business

issues, the Traffic Commission has not resolved this issue.

Discussion: Tina told the TC that general, traffic calming measures were needed in addition to the Stop Sign. No

discussion was conducted regarding this location.

Action: No action taken.

Traffic Commission Budget

Issue: The TC has previously requested that the VOM provide the TC with a small budget for the purpose of

utilizing a traffic engineer. As stated by the Village Manager at our March 14, 2023 meeting, a traffic expert is needed to evaluate dangerous traffic issues and make appropriate recommendations. He stated that the VOM would provide funds for Matt Carmody or one of his subordinates to attend some

of our meetings.

Ryan made a motion to adjourn the meeting at 9:30 pm. Laura seconded. All in favor.
