1. Call to Order: 7:36PM

2. Approval of December Minutes - Approved as amended

<u>Comments from Resident</u> – Mary Schaub attended. Minutes of meetings are available on website. Mary is an advocate for the new tree law and is interested in the ways the information will be communicated to the community. She has inquired about the replanting enforcement for 1523 Henry Street.

# 3. Correspondence:

<u>130 Beach Street</u> – Concerned about the trees that will be planted on 1010 Orienta Avenue. There was a Planning Board Meeting regarding the re-plantings of trees and it is detailed below under Old Business – 5h.

<u>Jefferson Ave</u> – Concerns was raised regarding the Army Corps of Engineers plans for flood control. All of the trees in Columbus Park

are planned to be removed and all of the trees lining the riverbank of the project are planned to be removed

# 4. Old Business:

- a. <u>749 Bleeker</u> Need to follow up on if tree was pruned or removed.
- b. <u>Rye Neck Social Action Research</u> Students doing research on how to raise community awareness on the value of trees. An eblast survey will be distributed and results will be analyzed. The results will guide in creating a tree friendly/tree supporting community.
- c. New Tree Law Enforcement Jerry is working on this. 1523 Henry violations were mentioned. Residents raised a question of reporting potential violations anonymously.
- d. <u>BROW Plans</u> BROW is "Beyond the Right of Way". Request owner's permission to plant on private property where street trees are not possible. Suggestion of tree scholarships was mentioned. A draft letter was presented for Trustees to send property owners receiving tree scholarships and their responsibility regarding the proper care of trees planted. It was suggested to include a brochure indicating benefits of trees to environment and potential cost savings for recipients. Marlene will research existing brochure.
- e. <u>Tree Inventory</u> Follow up with Jerry.
- f. New Trees The Tree Committee has an updated list of recommended species, locations (street vs park), salt tolerance and other important considerations. Trees will be heavily native types. Bare root trees may be better in the long run even though they start out smaller. In addition, mulch rings would protect the trees from trimmers cutting the bark.

# g. Tree Law -

- i. Suggested changes to the new law were made by the Planning Board. Changes will be sent to BOT first with a narrative (Beverley will prepare this). Village attorney will make the approved changes.
- ii. A tree bank was requested by the Planning Board. It will not be considered an "out" for adhering to the law but as a Planning Board option if necessary.

- iii. The most recent Village News included links to the Tree Law FAQs, the Tree Law and the Application for permit.
- iv. Marlene suggested we educate the pruning companies so they can advise property owners on what requires a permit.
- v. Request for a tree hotline was mentioned for reporting violations
- h. Planning Board Review of 1010 Orienta Ave Plant
  Selections There was a distinct code violation at the property. VOM needs to follow up on culpability and consequences for the clear cutting of all vegetation. The replacement of the tree canopy and the number and types of trees to be planted was discussed. A Zoom public hearing will be set up after the 1010 Orienta applicant provides detailed plan.
- i. <u>Tree Removal due to Con Ed Pruning</u> Matt is collecting data on this subject. Asking Con Ed for a cost comparison of burying lines versus getting crews up here after major storms was suggested. Marlene will take pictures of damaged trees in order to help build a case.
- j. Winter Tree Walk Occurred on 1/23/22 ay 1PM. 40 people attended. It was a cold but beautiful day. Two naturalists led due to the large number registered for the event. It was suggested that we plan for two groups going forward so we do not turn anyone away who is interested.

# 5. New Business:

- a. Matt shared some vital information regarding the positive financial impact of having trees 1. Increase in home value 7-15% 2. Reduction in crime rates, and 3. Reduction in energy costs. Deciduous Trees on the south side provide shade in the summer lowering cooling costs and allow sunlight in the winter lowering heat costs. Evergreen trees planted on the northeast side block wind in the winter and lower heating costs.
- b. VOM has assigned Village email addresses to all volunteers. Going forward all correspondence needs to be through this OUTLOOK portal. Existing email addresses can be copied and pasted in.
- c. Gail recommended free on-line Urban Forestry Forum sponsored by Yale. It is every Thursday morning at 11:30AM from Feb 3<sup>rd</sup> until April 21<sup>st</sup>.

- d. Gail suggested a garden walk for the community that highlights local landscaping in the VOM.

Good afternoon all. I just wanted to let you know what's happened with the application for site plan submitted for 1010 Orienta Avenue. Since there is a lot of public interest in the application, it behooves me to let you know of the Planning Board's latest action. Plus, the issue of enforcement of the illegal cutting of the trees should be addressed.

As you may know, a person claiming to be the owner of 1010 Orienta filed the applications to build a new home on the now cleared lot. (According to the official records, he is not the property owner but that is a separate issue.) They appeared at the 12/22/21 PB meeting when follow-up documentation was requested, and the applicants were informed that their proposed landscape plan (21 small trees) was inadequate.

They submitted additional material for the 2/9/22 meeting which did not address the PB's questions and concerns. After review of their latest submission and subsequent discussion, our Planning Consultant and Land Use Attorney determined that because the Village Code requires a site plan review to clear more that 25% of a lot, and the applicant and/or owner did not pursue said review or receive any approvals, this current application must be based on the conditions of the lot prior to the tree cutting. Furthermore, the applicant is subject to the new Village Tree Law and will be required to replace the trees in accordance with the schedule therein.

This was communicated to the applicant's representatives about a week ago and the AKRF memo to the PB is posted on the Village website for public access.

The PB <u>urges the Village to pursue action against the illegal removal of the trees</u>. The current owner of record is DeKalb Construction and we have asked the applicant to clarify who owns the property and who removed the trees. I have also spoken to both Dan Sarnoff and Frank Tavolacci about this matter, and they are aware of the details of this application.

We'll keep you posted if we receive additional information that is relevant to the tree removal and I'm happy to answer any questions you may have regarding this matter.

Hi Ellen,

I think this is a great idea and will add it to the agenda for our meeting this Thursday.

How do you envision it? Would the VOM plant the trees or would volunteers? Normally our committee doesn't do the planting, but this project might make a good community / school / volunteer effort, if the VOM agrees to it. If the trees are very small, they will need protection from deer for the first years. Willows, several types of oaks, and river birch are all excellent for river banks, but would be deer targets for a while.

My chief concern is how this project will fold in with the ACE flood mitigation project. As you know, I met with Tony Gelber and Kate Dehais (CFTE) about a week ago to talk about adding environmental approaches into the project. I know it fits with the current Army Corps thinking but Tony said his committee has not had a chance to talk to the mayor and trustees yet. It would be very discouraging to mount a large planting project, only to have it dug up or cemented over.

We do have a fair number of streams in VOM that would be good locations for new trees, but we should have some clarification before taking on the river banks.

# **Maintenance Pruning Proposal**

The Tree Committee respectfully asks the Board of Trustees to create a new budget item for a Maintenance Pruning Program for mature Village trees.

We seek \$60,000 annually, which would allow systematic pruning of approximately 67-100 trees per year. This number is based on the Village Manager's estimate that maintenance pruning, i.e. for health and structure, safety, and to lift the canopy, costs \$600-\$900 per tree:

- Health and structure pruning would remove dead or damaged branches that make a tree more susceptible to disease. It would remove branches growing in awkward positions. It would lighten the canopy so a tree would offer less wind resistance during storms.
- <u>Safety</u> would improve by removing dead branches that might drop on pedestrians.
   While this is extremely rare, it is a concern often cited by residents as a reason not to have trees.
- <u>Lifting the canopy</u> would prevent line-of-sight obstruction by a tree's lower limbs. It
  would remove branches that interfere with street or sidewalk traffic.

The Committee anticipates that the first years of this program might largely address trees requiring immediate attention. Our long-term goal is to divide the Village into zones and prune all the trees with maintenance needs within each zone according to a rotating schedule.
