# MINUTES OF MEETING OF THE TREE COMMITTEE HELD REMOTELY ON JANUARY 27TH AT 7:30PM

1. Call to Order: 7:36PM

2. Approval of December Minutes – Approved as amended

<u>Comments from Resident</u> – Mary Schaub attended. Minutes of meetings are available on website. Mary is an advocate for the new tree law and is interested in the ways the information will be communicated to the community. She has inquired about the replanting enforcement for 1523 Henry Street.

# 3. Correspondence:

<u>130 Beach Street –</u> Concerned about the trees that will be planted on 1010 Orienta Avenue. There was a Planning Board Meeting regarding the re-plantings of trees and it is detailed below under Old Business – 5h.

<u>Jefferson Ave</u> – Concerns was raised regarding the Army Corps of Engineers plans for flood control. All of the trees in Columbus Park

are planned to be removed and all of the trees lining the riverbank of the project are planned to be removed

# 4. Old Business:

- a. <u>749 Bleeker –</u> Need to follow up on if tree was pruned or removed.
- b. <u>Rye Neck Social Action Research –</u> Students doing research on how to raise community awareness on the value of trees. An eblast survey will be distributed and results will be analyzed. The results will guide in creating a tree friendly/tree supporting community.
- c. <u>New Tree Law Enforcement –</u> Jerry is working on this. 1523 Henry violations were mentioned. Residents raised a question of reporting potential violations anonymously.
- d. <u>BROW Plans –</u> BROW is "Beyond the Right of Way". Request owner's permission to plant on private property where street trees are not possible. Suggestion of tree scholarships was mentioned. A draft letter was presented for Trustees to send property owners receiving tree scholarships and their responsibility regarding the proper care of trees planted. It was suggested to include a brochure indicating benefits of trees to environment and potential cost savings for recipients. Marlene will research existing brochure.
- e. <u>Tree Inventory –</u> Follow up with Jerry.
- f. <u>New Trees</u> The Tree Committee has an updated list of recommended species, locations (street vs park), salt tolerance and other important considerations. Trees will be heavily native types. Bare root trees may be better in the long run even though they start out smaller. In addition, mulch rings would protect the trees from trimmers cutting the bark.
- g. <u>Tree Law –</u>
  - i. Suggested changes to the new law were made by the Planning Board. Changes will be sent to BOT first with a narrative (Beverley will prepare this). Village attorney will make the approved changes.

<u>VOTE</u>: The committee voted unanimously to send the Planning Board changes to the Board of Trustees.

- ii. A tree bank was requested by the Planning Board. It will not be considered an "out" for adhering to the law but as a Planning Board option if necessary.
- iii. The most recent Village News included links to the Tree Law FAQs, the Tree Law and the Application for permit.
- iv. Marlene suggested we educate the pruning companies so they can advise property owners on what requires a permit.
- v. Request for a tree hotline was mentioned for reporting violations
- h. <u>Planning Board Review of 1010 Orienta Ave Plant</u> <u>Selections -</u> There was a distinct code violation at the property. VOM needs to follow up on culpability and consequences for the clear cutting of all vegetation. The replacement of the tree canopy and the number and types of trees to be planted was discussed. A Zoom public hearing will be set up after the 1010 Orienta applicant provides detailed plan.
- i. <u>Tree Removal due to Con Ed Pruning</u> Matt is collecting data on this subject. Asking Con Ed for a cost comparison of burying lines versus getting crews up here after major storms was suggested. Marlene will take pictures of damaged trees in order to help build a case.
- j. <u>Winter Tree Walk –</u> Occurred on 1/23/22 ay 1PM. 40 people attended. It was a cold but beautiful day. Two naturalists led due to the large number registered for the event. It was suggested that we plan for two groups going forward so we do not turn anyone away who is interested.

# 5. New Business:

- a. Matt shared some vital information regarding the positive financial impact of having trees 1. Increase in home value 7-15% 2. Reduction in crime rates, and 3. Reduction in energy costs. Deciduous Trees on the south side provide shade in the summer lowering cooling costs and allow sunlight in the winter lowering heat costs. Evergreen trees planted on the northeast side block wind in the winter and lower heating costs.
- b. VOM has assigned Village email addresses to all volunteers. Going forward all correspondence needs to be through this OUTLOOK portal. Existing email addresses can be copied and pasted in.

- c. Gail recommended free on-line Urban Forestry Forum sponsored by Yale. It is every Thursday morning at 11:30AM from Feb 3<sup>rd</sup> until April 21<sup>st</sup>.
- d. Gail suggested a garden walk for the community that highlights local landscaping in the VOM.

# 5. Correspondence:

<u>205 Melbourne -</u> A branch of a tree removed by VOM had grown around an overhead wire. A portion of the branch was left hanging from the wire and was in risk of falling. It could have caused major damage if it fell. TC was emailed by resident and Jerry Barberio contacted Verizon, which came and removed the branch. The tree was leaning and created a hazard for children at the neighboring nursery school, as well as for pedestrians. <u>130 Beach –</u> Resident is questioning removal of the tree at 205 Melbourne.

# **Old Business:**

- a. <u>Across the street from 749 Bleeker ROW –</u> Gail to follow-up with Jerry Barberio on assessment of tree marked for removal. Trying to save tree for the benefit of the ospreys.
- b. <u>1505 Harrison Ave.</u> Application pending for removal of two protected trees.

- c. <u>1505 Stoneybrook Ave.</u>– Resident requested removal of 12 trees. Request was denied.
- d. <u>Rye Neck Social Action Research –</u> Beverley reviewed the draft of survey for distribution. Once approved by the VOM, the survey will be emailed to residents.
- e. <u>New Tree Law Enforcement –</u> 990 The Parkway to be reviewed by Jerry. Tree was topped and severley pruned. Frank Tavolacci, VOM Building Inspector, confirmed ROW and a permit. 1037 Orienta – Tree removal application denied for protected trees. This helped to prevent clear cutting.
- f. <u>New Trees –</u> Order was placed for 36 trees to be planted in the fall.
- g. <u>Tree Law –</u> Awaiting approval of requested revisions by Board of Trustees.
- h. <u>Tree Tags for New Trees</u> Gail is working on the sample.
- i. BOT Tree Scholarships Awaiting approval from AG for BROW
- j. <u>Tree Hotline –</u> A uniform calling list is being established to report possible illegal removals. In the meantime, Dennis Drogan offered his numbers for emergency calls regarding cutting and pruning. His numbers are (914) 777-7731 (office) and (914) 330-6753 (cell).
- <u>Tree Damage by Con Ed –</u> Strategy and filing of damage is being organized. George Latimer offered assistance on dealing with Utility Companies.

## 6. New Business:

- <u>"Tree Donuts" watering system test planned –</u> Donuts collect rain water when available and helps water the trees thereafter. It reduces labor and fuels cots. Protects younger tress from tree damage.
- b. <u>314 Carroll, Relocation of WJWW equipment -</u> DPW General Foreman Mark Ferraro met with WJWW and they were able to install equipment without harming the tree roots.
- c. <u>Financial Effects of Planting Trees Around Private Residences -</u> Matt is working on this.
- d. <u>Possible Joint Book Discussion –</u> Working on selecting the right book and partnering with Mamaroneck Library.
- e. <u>TC Committee Field Trip</u> Nora is checking to see if The TC can do a field trip. Gail volunteered to guide a tour at Sheldrake Environmental Center. Bub Walker Park by I-95 was mentioned as well.



## Attachment – 130 Stuart Ave Regarding Implicit Bias in Tree Canopy

Dear Chairs and Members of the Tree Committee,

I am again writing to encourage the Tree Committee to be pro-active in ending the implicit bias in Village Tree planting. I hope that this year a substantial portion of the tree planting budget will be utilized for trees in historically underserved neighborhoods. Below is another article about this widespread problem.

Rochester's trees are celebrated, but not everyone gets to have their time in the shade



Additionally, I urge the TC to revisit the Village's recommended tree list. The latest revision that was done without BOT review and approval, and in my opinion, has resulted in a number of questionable deletions from the BOT approved list as well as some questionable additions.

## Additions:

Juglan cinerea, a tree that has numerous problems as a street trees. It's been devastated by butternut canker disease, as well as a plethora insect pests such as bark beetles, butternut curculio, husk flies, lacebugs, nut weevils, and wood

borers. Additionally, its roots produce a toxin that spread 60-80 feet from it's base that stunt or kill many commonly planted ornamentals.

Cornus florida - Native dogwoods, even planted in the best of conditions and prophylactically sprayed for anthractnose, are very prone to anthracnose. I believe a survey of dogwoods planted by the Village over the last few years would indicate that few have thrived or even survived.

## **Eliminations:**

Quercus Shumard - an excellent, fast growing native oak

Quercus Phellos - another excellent, fast growing native oak

Acer saccharum - the quintessential, native maple for fall color

Acer freemanii - an excellent hybrid of two native maples, rubrum and saccharum

Ulmus americana - notwithstanding some structural issues that can be overcome by better plant selection and formative pruning practices, arguably the most successful variety planted by the Village in the last decade

Please consider revisiting the list and refer it to the BOT for approval. Even if you don't please let the Planning Board's landscape consultant know about the change as she has been including the previous list in her memos to applicants.

Thank you for your email.

The tree we have scheduled in front of your property is a redbud, a small, flowering tree. I believe there are power lines above the right of way, so a tree planted in that space needs to be less than 30' at maturity.

According to my notes, someone requested a replacement for the tree that had been removed. I apologize if my notes are incorrect.

It is not too late to change the location for the new tree if you would like. I can make arrangements with Jeff Ahne, our Parks Foreman, for a return visit and let you know about it in advance so you can be part of the discussion. The Village is working on building up the canopy in the rights of way along our streets to lower the summer temperatures, clean the air, and provide all the other benefits that trees convey.

You are of course at liberty to plant your own trees elsewhere on your property, so long as they are not in the Village right of way. If you don't want a tree in front of your house at all, we will find another location for it.

Ms Sherrid and Ms. Koller,

My husband previously sent an email on this matter a couple weeks ago but has received no response.

My name is Amanda Neilson. My family and I reside at 702 Prospect Ave. and have lived here for nearly 20 years. Recently, I noticed some white spray paint marking an area in front of our home on the road. My neighbor informed me this was placed by the tree commission with the intention of planting a tree at that spot. This concerns me. This is NOT the right spot for a tree in our yard.

On Christmas Eve, 2020, the large beautiful maple tree in front of our home was cut down by the tree commission. We did not receive any notice of this. It was very distressing and has been sorely missed. I appreciate the desire to replace a tree, however the new spot will be directly in the middle of our front lawn, which is an awkward placement, as well as being a high trafficked spot from the many neighborhood children who play on our front lawn, using it as a sort of field/playground.

My next concern is we have not been informed with any details. What type of tree is planned? The city has planted many crab apple trees in the area and they are messy which I would like to avoid.

Please do not plant a tree in this location! If there must be a tree than perhaps we can replant a tree back where our old maple tree in the first place- immediately south of the large rock. Otherwise, I do not see the need for a tree here. I love trees, but our yard is small, and I dont see the need for one as planned. If, for some reason, a tree must be planted please let me know the reasons and particulars. I would prefer to hire a private landscaper to plant a good tree further over, in a more attractive and appropriate location closer to our driveway and not in the middle of the lawn.

Action Research for Community Change is a student-centered social science research think tank based on the book, Student Research for Community Change, that Dr. Feit co-authored with Dr. William Tobin a sociologist from the Kenan Institute for Ethics at Duke University.

Dr. Feit and Dr. Tobin wrote the book based on 10 years of research that demonstrated that high school students can make a positive impact in their communities by providing local organizations with empirical research that supports policy development.

Rather than a typical curriculum, Action Research teaches students to apply social science methods to address issues that when embedded in their communities, are multi-faceted and often entangled with the beliefs and needs of community stakeholders.

Our recent clients have included the Community Resource Center with a study on access to affordable housing and transportation, The Westchester Joint Water Works, a study on public perceptions of water quality, and the Village of Mamaroneck, for whom last year, we conducted a study on legislative limitations on the use of gas-powered leaf blowers -

To identify issues in our community, we invite leaders of local organizations to speak with us about the challenges they face as public service organizations. In a series of interviews with community leaders, we consider the challenges they share with us and identify an area on which to focus our study.

This year the Action Research students conducted a study for the Village of Mamaroneck's Tree Committee, Chaired by Mrs. Beverley Sherrid. We investigated residents' perspectives on sustaining our urban forest and perspectives on new legislation adopted in 2020 regarding the removal, planting, and preservation of trees that support environmental goals in our community.

We interviewed Mrs. Sherrid, to learn about her experiences as a conservationist who is working to create awareness of the importance of the urban forest as a means to combat air pollution, erosion from climate change, and protect the beauty of our community - Urban forest was a new term for us. The urban forest refers to trees in built-up areas that provide a means to preserve indigenous and air purifying trees - particularly, old growth trees.

From Mrs. Sherrid we learned that in Fall 2021, the Village Board of Trustees, approved legislation that requires homeowners to apply for permits to remove trees from private property. The law restricting removals applies to protected trees only, i.e. trees 8" in diameter at 4 1/2' from the ground. These trees require a permit and have a replanting requirement - removing them without a permit entails a fine. The fines for removing a tree without a permit are substantial and can run into thousands of dollars. After two detailed conversations with Mrs. Sherrid, she identified resistance from private property owners to the 2020 legislation that clearly articulates how people should manage the trees on private property.

Action Research members generated the research question: What are the perspectives of homeowners and renters in the Village of Mamk on the removal and replacement of trees according to the 2020 legislation?

We decided on a qualitative study for which we developed a survey to determine the views and attitudes of homeowners regarding the trees in the Village of Mamk that are located on private property.

We began by identifying what data would be the most beneficial to the Tree Committee, including residents' demographic information, such as age, home ownership, decision-making regarding trees, the presence of children and pets, their past decisions regarding the trees on their property, and their current beliefs about the usefulness of trees in our community.

Robert Ingenito, Public Information Officer for the Village and Mrs. Sherrid, reviewed our survey. This resulted in both English and Spanish versions being distributed over a three-week period in the Village's eNewsletter during March 2022.

We garnered 18 responses to the English version of our survey, and no responses on the Spanish version. Of those respondents, a full 77.8% reported voting in local elections. According to research on voter turnout in local elections conducted by Portland State University an average of only 15% of registered voters participate in local elections nationwide - if voter turnout is an indicator of civic engagement, we had heard from civically engaged individuals.

The demographic profile of respondents to our survey showed that they were between the ages of 31 to 66+ years old, homeowners (83%) who made decisions about trees on their properties, and roughly half had children and/or pets. We queried whether children or pets were present with the idea that those with either, might value trees more than residents who do not use their properties for child or pet recreation.

The Village's tree legislation requires that if a tree is removed a new one must be planted. 44% of respondents had a tree removed in the past 3 years and 55.6% had planted a new tree indicating that these homeowners were adhering to the Tree law.

Therefore, based on the demographic data we collected we concluded that the respondents were those most likely to have voted on the Village's tree legislation and in view of their following the law, might also be citizens who supported it. This was further supported by the 38% who reported that an arborist had evaluated the trees on their property within the past three years. That data point generally corresponds with the 44% who had removed trees.

78% of respondents who had trees removed did so because their trees were dead, diseased, blocked light, or had roots that might cause structural damage. There were no respondents who removed trees for reasons such as clearing a lot, obstructing a view, or issues with raking.

83% reported that they care about future environmental impact of the species of trees on their properties and 94% said they were aware of the 2020 Tree Law. Only 16% said that they would replace an existing tree with an ornamental tree rather than one that provides an environmental advantage.

When it came to assessing summer temperatures, air quality, floods, and property values, 100% of respondents said that these issues are very important (72.2%) or important (27.8%).

Finally, 100% of respondents supported a variety of reasons for preserving the urban forest including shade, privacy, attractiveness, flood protection, light blocking, with 55.6% voicing concerns about falling branches, roots interfering with foundations, or reducing open space.

Our data and analysis suggests that it is likely that the Tree Survey respondents are civically engaged, supported the Tree Law, and understand the value that trees bring to our community. Since the eNewsletter is available to all residents, the small number of respondents might mean that many local residents are not responsive to surveys and/or the media communication from the Village of Mamaroneck via eNewsletters.

We concluded that If the Tree Committee wishes to expand active interest in the Village's preservation of the urban forest, it will be necessary to find alternative ways of canvassing residents to engage them in the aims of tree conservation.

## EMERGENCY CONDITION

A condition in which severe weather, storms, natural or non-natural causes severely affect the integrity of a tree, posing an immediate threat to life, property or the general public. P.2

318-8 K. Emergency Removals. If the Village Manager or the Village Manager's designee determines that a tree is a dangerous tree, the Village Manager or the Village Manager's designee may grant a permit for the immediate removal of the tree without following the procedures or requirements otherwise required by this section, including replacement of trees where required, but no tree 18 DBH or greater may be removed on an emergency basis by reason of disease without submitting to the Building Inspector a detailed report by a certified arborist justifying the removal. Removal of any tree is permitted by any person when there is an actual or ongoing emergency condition threatening life or property, the immediate removal of a tree is necessary for the protection and preservation of life or property and there is no time to wait for granting of a tree removal permit. Within three business days of removal, documented evidence such as photographs, along with a completed tree removal application, must be submitted to the Village Manager or the Village Manager's designee setting forth the nature and extent of the immediate threat. A tree that has fallen because of non-manmade conditions may be removed by the property owner prior to filing a completed tree removal application, provided said application, along with documented evidence such as photographs, is filed within three days of removal. Failure to submit the required documentation within three business days is a violation of this chapter. A property owner is not required to remove a fallen tree that is not dangerous and does not cause a public obstruction.
