Suggestion was made for the Tree Committee to continue to find ways to educate and build community interest regarding the benefits of a tree canopy.

Hi Jerry and Jeff,

Clean Up Day had light attendance this year, but the people who participated worked hard.

One of the Shore Acres locations was the Bird Sanctuary along Guion Creek. You may remember that we met there last year with Gail because of complaints by residents near the sanctuary about the invasive vines choking the trees and the possibility that some of the trees are hazardous.

Saturday's volunteers are concerned that the vines need to be removed and the trees need to be inspected. They also discovered that people have been dumping yard waste on this land although we don't have any documentation of who is doing it.

Finally, there is continued concern that the trees and brush at the bend of the road approaching S. Barry are creating visual obstruction and a driving hazard. We would like the Village to clear the lines of sight.

Would it be possible for us to meet there again for another look, and for the Village to take care of these problems?

Hi Kimberly,

I'm so glad you reached out to me with your tree questions! Since this is "official Village of Mamaroneck tree business", I'm replying from my VOM email and cc'ing Beverley Sherrid, cochair of the Tree Committee. Question 1: The shoots coming out of the trunk are called "suckers" and you are absolutely correct in thinking they need to be trimmed. Since the suckers are way below the tree's canopy, they tend not to produce much sugar for the tree, but they do take water and nutrients. The best time to remove suckers and prune back branches is in the fall after the tree has dropped its leaves and is dormant. If it is a private tree on your property, you can remove the suckers yourself with pruning shears. If the tree is in the "right-of-way" (ROW), it is a public tree and one of the VOMTC's "Citizen Pruners" can trim it for you.

About your second question, we need to determine if the removed tree was in the ROW. If it was in the ROW, Beverley will assess whether or not a new tree can be planted there. However, judging from the photo, it looks like the tree was very close to the intersection. Trees are now planted at least 20' from an intersection. If you would please "Reply All" with your address, we will look into whether or not it's possible to put in a new tree.

Lastly and in case you're interested, the Village of Mamaroneck periodically offers free, handson workshops on how to prune trees (just the lower, easy to reach branches. The dates of the workshops will be posted on the VOM website.

I walked this area with our mason and we have "flashed" numerous areas to make them safer. However, there are a number of sidewalk slabs with significant damage and/or lift that simply "flashing" can not repair. Could be between 50-70 linear feet of sidewalk that may need replacing due to roots. One issue is a set of roots left underneath a sidewalk from an old tree years ago. This is right next to another lift issue.

Thank you for writing.

We read the most recent Town code regarding trees last year while completing the new Village tree law. While the Town does talk about replanting and restoration after private tree removals, the requirements seem to be handled case by case by the its Environmental Planner. Property owners are required to submit plans showing existing trees, including those to be removed, with their sizes and species, and to identify replacement trees with location and species. I don't see any requirements about size.

I'm attaching a copy of the TOM tree code. This version is dated June 22, 2021. I don't know if there have been subsequent amendments. The relevant section for you is 207-6 B. You and your arborist may find it helpful, or may spot something that I missed.

Sorry to bother you, but I'm trying to confirm the Town of Mamaroneck's requirements for replacing trees that are removed on private property. I know that the Village law specifies 2-2.5" caliber. I tried looking on the Town website but couldn't find specific criteria.

I will likely be making additional comments to the Planning Board regarding the proposed replacement trees at 1010 Orienta Ave. My arborist was here today and he said that the Town of Mamaroneck has a 3" criteria and New York City has a 3-3.5" criteria. I want to make sure his statement was correct before I put it in my comments as a request. (The current planting plan complies with the current Village requirement, but that doesn't mean it is the most appropriate approach for this large property that was clearcut.)

Attachment 23 Tree Nursery Update

Hi all,

This morning, Jerry, Jeff and I met at Bud Walker Park (located adjacent to the northbound side of I-95 going from Fenimore Road to corner of Grand Street & Plaza Avenue). I have attached several photos of the site. Outlook is being difficult and I will have to attach the rest of the photos to a separate email.

The plan is as follows:

- Part of the footpath will be moved a few feet closer to I-95 to make more space for more baby trees.
- The raised beds in the vegetable garden will be moved and situated between blocks of baby trees.
- The fenced in area will be enlarged.
- Jerry will purchase "pots-in-pots"* in which the trees will grow.
- The trees will be 1/2" DBH and about 6' tall.
- A water line will be hooked up to existing water pipes under Fenimore. Soaker hoses and another kind of hose (I don't recall the name) will go through the nursery and raised vegetable beds.
- We will also plant tree seeds in smaller containers. The seedlings/saplings will be transplanted to progressively larger containers until they will be ready for the pots-in-pots.
- We will establish a sub-committee of the TC of TC members who will care for the trees. This will involve a planting day (more on that below) and watering the trees.
- In September, the VOM will have a celebration to inaugurate the new tree nursery and plant our first batch of baby trees in the pots-in-pots.

*Pots-in-pots is what I am calling a large pot that is halfway down in the ground plus another pot that sits within the first pot. The pot that sits within the first pot will have the soil and tree and will be lifted out of the ground when the tree is ready to be transplanted to its permanent location.

Either the zipe file attached to this email OR the zip file in a separate email also contain photos of 2 trees that have bittersweet vine choking the trees. Jeff will have the vines removed. Another photo or 2 are of an open area adjacent to the bocci court, that can accomodate 3 tall trees.

I welcome any questions or comments. Let's also discuss all of this at our May TC meeting.

I think we can provide it because our new tree law lets up put Village trees on private property. A few weeks ago someone challenged that, however, so now we are waiting for confirmation from NYS attorney general's office.

So I can't give you a definite yes right now.
