# Draft of Minutes of Meeting of the Tree Committee held remotely on July 28, 2022 at 7:37PM

PRESENT:

Nora Lucas, Trustee Beverley Sherrid, co-chair Gail Koller, co-chair Marlene Star, TC member Joe Colombo, TC member (by phone) Sara Mignano, TC member Krishna Finkenberg, VOM Resident

- 1. Call to Order: about 7:37 PM
- 2. Approval of June Minutes GK motions, JC seconds, all in favor
- 3. **Resident at Meeting** Krishna Finkenberg has experience planting trees on a farm in upstate NY. Suggested planting younger and smaller trees as well as using more obvious staking around newly planted trees to protect them.

# 4. Correspondence:

- a. 1040 Nautilus property owner filed for permit to remove trees. Jerry denied application and owner appealed. Land Use records subsequently established that property has a Planning Board-approved landscaping plan, so Planning Board needs to review. GK motions to put review on hold until Planning Board reviews it. JC seconds motion. All in favor.
- b. Email from 130 Beach regarding "implicit bias" in tree planting practices. GK replied that there is no ROW in areas that most desperately need trees (Washingtonville neighborhood) and asked for suggestions of addresses that could accommodate trees.
- c. 130 Beach discuss when Jerry is in attendance
- d. 629 Fairway requests meeting with TC rep about replacement tree

# 5. Old Business:

 a. Tree Law – Months ago, TC approved changes in law requested by Planning Board. Village attorney has comments addressing: TC's intent

- i. a tree bank for Planning Board use only if applicant cannot provide space for replacement trees
- ii. if tree falls because of natural causes then a permit should not be required. Discussion that photo documentation and report of tree falling because of natural causes should be required.
- iii. Motion to approve TC's response to attorney.
- iii. Tree Removal Permit for tree removals should be posted on tree(s) the day the tree is to be removed.
- b. Tree nursery 1 raised bed is available to start tree seeds at Bud Walker Park Community Garden. GK, in cooperation with science teacher, to plant tree seeds in 1 raised bed at Westchester Day School's garden. Trees can be donated to Community Resource Center for distribution.

# 6. New Business:

- a. VOM received grant for sidewalk improvement. Can that provide opportunities for tree planting sites on Halstead?
- b. Trees on Richbell Road have mulch piled up against bases of trunks. VOM to move mulch away from trunks
- c. Orienta Avenue near Sylvan Lane VOM dead tree needs to be removed
- d. Cluster of mostly dead pines near 430 Orienta Avenue needs to be removed
- e. Beverley has list of public and private tree removals
- f. 515 Prospect ROW tree was topped. Can violation be issued
- g. 705 The Parkway tree removed on Saturday and reported as violation. Was violation issued?

Please enlighten us specifically as to what in our email of 6/7/22 caused you to deny our tree application of 7/1/2022.

Hi,

I will be handing off your issue since you have, in my opinion, joined a small group of people in the Village who require extra attention from the BOT with your comments.

Before I go, I want to make sure that the approval you received in the past for the removal of 10 trees is fully executed by planting 10 trees as per our code and new tree law. The only reason for my denial was the email you sent on 6/7/22:

My message sent was addressed to the Board of Trustees and the Tree Committee...I will repeat the question...Is it rational to have to plant 10 trees on our property as a consequence for being proactive as described in our email of June 4th (please read). We believe that the law must be revised in reflecting the removal of our dangerous trees. We also seek relief in our having to plant the 10 trees.

Until that is resolved, I will deny any application for the removal of additional trees on your property.

Dear Chair and Members of the Harbor and Coastal Zone Management Commission,

I am writing about the plan to create a tree nursery in Bub Walker Park, a discussion of it from the May Tree Committee agenda is below.

Bub Walker Park is a narrow strip of land that lies between the Sheldrake River and Interstate 95, it runs from Fennimore Avenue to Plaza Drive. Upon information and belief, a good percentage of the park lies in the <u>Regulatory Floodway</u> (floodway). The floodway has a higher standard of regulation than the Floodplain, "The floodway is that area that **must** be kept open to convey flood waters downstream."

At minimum I believe this project requires SEQRA review and a Floodplain Development Permit, neither of which, as far as I know have been initiated at this time. Considering the proposed use, which will require the use of fertilizer and perhaps pesticides, and location, adjacent to a impaired waterway, I believe a consistency review of the plans by the HCZMC would also be beneficial.

Finally, I believe there are a number of alternative locations that would be more suitable from a horticultural, environmental and flood mitigation perspective. There are area in both the east basin and west basin of Harbor Island Park as well as the remediated Taylor's Lane site that come to mind.
