# Attachment 3 540 Munro, Questions about location for new street tree And pruning responsibilities

Thanks for clarifying.

Con Ed is responsible for branches threatening their power lines, although generally only the top one or two are theirs. It would actually be dangerous for you or an untrained arborist to work around those lines.

The Village is responsible for the trees planted along the street in the right of way (the strip of grass between pavement and curb). Generally maintenance refers to removing a dead, dangerous or diseased tree, or to pruning, not to trimming the roots.

I hope you settle in and enjoy Mamaroneck. It's a wonderful place to live.

### Attachment 4 330 Beach – Implicit Bias and other matters

Dear Chair and Members of the Tree Committee,

I am writing basically to update a number of issues I have previously brought to the Tree Committee's attention. **Updates in bold,** everything else is from previous emails to the TC.

### BROW Planting 7/25/22 email below

For the new TC members who aren't aware, in 2018, after spending considerable time and money the Village adopted a Tree Management Plan (TMP) <u>here</u>. In part, the TMP said this about BROW planting

"Should VOM decide to pursue such a program, the first step is to have the village attorney review the Association of Town's finding that "local municipalities have the authority to enact a local law to provide trees to property owners according to the Municipal Home Rule Law, §10(i)(a)(ii)(12) of the NY Const., Art IX, §2 under their police powers" (Wegener 2014). And then to have the trustees pass a resolution approving such a program."

I don't believe that the first step above has taken place. Without following the above actions, when the Village does BROW planting it is in violation the NY Gift and Loan Clause that prohibits the use of public funds for private benefit.

The 2022 Planting List indicates two BROW plantings, visiting the locations I identified potentially three other BROW plantings.

I am copying the Village Attorney and BOT in case I got this wrong and the Village has met the legal requirements to do BROW plantings.

Below is an image of two trees planted BROW at 207 Grand last fall. As I understand it, the Village has asked the Attorney General for an opinion on the legality of "Tree Scholarships". As I understand it the Village has either not had a response or has had negative response it is not making public. Until that response is made in the affirmative and the Village passes the above mentioned required legislation this practice remains a violation of the gift and loan and creates a liability for the Village. For those reasons it should stop.

### Tree Placement

The Planting List called for two London Plane trees to be planted 25' apart at 536 Orienta Avenue. Below in an image of the two trees.

This is what the Tree Management Plan says about the spacing of trees.

Planting Specifications. VOMTC has created guidelines for tree plantings that were approved by the village trustees in 2010 as an addendum to Code 318-7. This guideline follows:

- No trees that mature at a height greater than 30 feet are to be planted below Con Edison distribution lines.
- Trees that mature at less than 40 feet shall be planted at least 30 feet from any adjacent tree
- Trees that mature at more than 40 feet shall be planted at least 40 feet from any adjacent tree.

The same guidelines are linked to on the TC's webpage. It is hard to understand why these two trees were scheduled to be planted as they are.

London Plane trees are giant trees growing to 100 feet tall and 60-80 feet wide. If anyone has any doubts please take a walk by the two giant London Planes in the triangle at Orienta and Old Post Road, they are planted 70' apart. Planting tree too close creates future disease and maintenance issues as the tree mature and conflict with each other.

The Planting Specifications adopted by the TC and the BOT years ago are common sense and should be followed.

The Tree Management Plan similarly contains important information for guiding the TC's work.

Based on the two images below the practice of planting trees too close in violation of Village guidelines continues. The first image of two Oaks on Stanley Avenue planted less than 20ft apart when the guidelines are at least forty feet apart. The second image is of two cherries planted less than 10 feet apart on Melbourne Avenue when they should be at least 20 feet apart. There are numerous other examples. Please see that any future plantings respect the adopted commonsense guidelines.

### Implicit Bias in tree planting

Almost all scheduled street tree planting locations are again in the most affluent Village neighborhoods, almost half of them in Orienta. Over the last ten years over a hundred trees have been planted in the Shore Acres and Orienta and almost none in the Mamaroneck Avenue School neighborhood and other less affluent, underserved neighborhoods.

Nothing has changed. The TC and Village claimed in a 2019 grant application that "the Village is committed to focusing on additional tree planting for low-to-moderate income residents first as those residents tend to live near .......what is considered the Village's heat island." and focusing those grant funds on planting trees in the Mamaroneck Avenue School (MAS) neighborhood. However, after not receiving the grant, in the ensuing four years the Village has not planted one tree in that neighborhood.

Last summer, at the TC's request, I spent a considerable amount of time compiling a comprehensive list of suitable locations in the MAS neighbor. The result? Out of the 238 trees purchased for planting last year not one was was planted in the MAS neighborhood.

Where is the commitment? I hope that this year the TC and Village will live up to it's commitment.

List of and care of the Village's "significant trees"

**From an 8/2/21 email to the TC** -The oldest known tree in the Village, the Tompkins Farm Oak (TFO), is in sharp decline as can be seen in the photo below. The crown has thinned significantly and there are multiple branches, from the bottom to the top, where terminal end growth has stopped.

This is especially sad for the Tompkins Farm Oak neighborhood which for thirty years led the efforts to protect the tree from damage by developers and the Village.

I hope the Board will advise the BOT to take prudent steps to determine the present condition of the tree and any steps that may prolong it's life.

My suggestion would be that the Village hire a Consulting Arborist to evaluate the TFO.

Please don't let the Village Manager hire Frank Buddingh or Ken Almstead of Almstead Tree.

Mr. Buddingh is not a consulting arborist and is conflicted because he was the arborist the Village hired in 2012 to greenlight the work, against the NYSDEC Forester's recommendations, that likely put the kiss of death on the TFO.

Ken Almstead is a consulting arborist but his company will get paid to do any work on the tree. Also, it was Almstead Tree that was hired by the Village in 2012 to supervise the Pine Street excavation below the TFO and allowed contractor to ignore the preservation plan for the TFO.

The new tree law passed in 2021 claims that "No later than August 1, 2021, the Village Manager will cause to be prepared a list of significant trees. The list will be available for public inspection in the Village Manager's office." Has this been done, if not is there any idea when it will be? In either case I believe the Tompkins Farm Oak should be on the list and the Village at the very minimum should evaluate it's current condition.

### Tree Law provision

The Village Manager, regarding the removal of a tree on private property, wrote to a property owner "We need the signature and sign off of the next-door neighbor since the tree is on the property line or very close to the PL." Please let me know if this is a requirement of the new tree law or this is something the Village Manager has made up.

I hope you will address the issues raised above at your next meeting.

Dear Chair and Members of the Tree Committee,

Please see below an image of a large piece of deadwood that fell out of the Tompkins Farm Oak last night

Over a year ago, I wrote the TC -

"Six months ago I wrote the TC about the marked decline of the Tompkins Farm Oak (TFO), the oldest tree in the VOM, my original email is appended below. I have attached a recent photo below that shows the large pieces of deadwood overhanging the Pine Street roadway and cars that park under the canopy.

Trustee Lucas, who lives across the street, is knowledgeable of the history of community efforts to protect the TFO as well as the history of the Village ignoring common sense preservation recommendations from the NYSDEC Arborist that has led to it's untimely demise.

Except for putting my email on an agenda I don't think there has been any discussion of teachable moments from the TFO's untimely decline or steps going forward for possibly extending it's life and mitigating dangers from it's continuing decline. I hope the TC will take this up in the future."

I don't believe than in a year and a half any action has been taken to either evaluate whether anything can be done to help preserve the Tompkins Farm Oak's life or remove the clearly dangerous deadwood in the tree.

As I have expressed before, for those in the neighborhood who worked for years to protect this tree, it's disappointing how little interest the Tree Committee or Village have shown in caring for and preserving this piece of Village history.

I urge you to take some meaningful action, if only to reduce the liability.

#### Tree removal activities in accordance with Village Code Chapter 318

#### TREE REMOVAL PERMIT APPLICATION SUBMISSION REQUIREMENTS:

- The application for a Tree Removal Permit shall contain the address of the project including the section, block, and lot along with the name, phone number and email address of the owner, tree contractor and when applicable ISA certified arborist (tree expert) with completed ISA Assessment Form as well as a description of the project. The entire application must be filled out and signed to be accepted.
- The permit must be filed with the Building Department and will be valid for ninety days (90) or a permit extension will be required.
- Each application shall include the following information.
- Site plan or survey and photos showing location of trees to be removed (type and size to be noted) including a copy of any land use board approved site plan and certifications applicable to the tree removal(s) proposed.
- A list of tree species specifying types and DBH sizes of trees to be removed and the reason for removing the trees.
- Permit fee, and any other information to support the application.
- At the time of application submittal, the trees proposed for removal must be clearly marked with ribbons or stakes on site for Village staff review and verification.
- Depending on the scope of the project, the Village may require:
- A written statement from an ISA certified arborist or other tree expert stating the condition of trees requested for removal which may include a certification statement that all trees removed shall be removed and/or replaced in accordance with the approved permit and all provisions of Chapter 318 of the Village Code.
- A tree preservation plan showing trees which are to be preserved and protected. Methods for tree
  preservation in areas affected by construction activities shall meet standards set by Westchester
  County Best Management Practices Manual.
- Supporting documentation prepared by an ISA certified arborist attesting to any statement that a tree(s) is considered dead, dying, diseased or hazardous. The ISA Basic Tree Risk Assessment form is an industry accepted supporting document.
