

Thanks to a stuck nearby low, enough moisture is around to spark a minor shower chance early this morning again later in the afternoon, which could also produce a brief storm. However, both risks are isolated which leaves the day fine otherwise for most outdoor plans. Tomorrow is largely fine until rain arrives mainly after dark, giving us an active night (particularly toward morning) and early Friday. This will give us an active period of at least scattered showers and storms about until clearing by the second half of the day. Much nicer and pleasant weather then takes over for the weekend.

Dear Chairman O'Rourke and Members of the Planning Board,

The Tree Committee strongly recommends the use of <u>CU-Structural Soil in</u> addition to porous paving in new site plan approvals by the Planning Board. The use of CU-Structural Soil under paved surfaces would be another tool for mitigating the Village's flooding problems following heavy rainfall.

Our committee has been researching a soil mixture called CU-Structural Soil, developed by the Urban Horticulture Institute at Cornell University. The mixture was designed for use under streets and sidewalks next to trees to prevent roots from lifting the pavement while they grow and seek sources of air and water. The Village is already introducing this product in new sidewalk repair projects. It is strong enough to support concrete or asphalt paving and the pedestrians or vehicles that use it.

In reading the *Guide to CU-Structural Soil*, we learned that the mixture is very effective at retaining rainwater under porous paving, with or without trees. It is superior in several ways to the gravel generally used as a base: it is fabricated for easy installation by contractors; it captures and retains significant amounts of rainfall; it supports healthier growth of trees that may be part of a site plan.

I am attaching copies of both the *Guide to CU-Structural Soil* and an extract of passages relating to the benefits of using the mixture under paved surfaces.

If possible, we'd like to attend an upcoming January Planning Board meeting to discuss this recommendation further.

Thank you for considering this recommendation for including structural soil in site plan approvals.
