2024.2.7 Trees for Inspection Report

Thank you. Very helpful.

I completely agree about removing trees (and river debris) for public safety.

I think the stumps and roots should be left in the ground in locations such as river banks and the sanctuary – the roots continue to stabilize the ground for years to come, and both stumps and roots have significant wildlife benefits. These are sanctuaries, not soccer fields.

I would like to talk further about taking dead wood out of the sanctuary. Again, it has enormous role in ecological life cycles that we can't offer in regular parks or on (most people's) private property/lawns. Can we talk later?

In regard to this list.

Carroll street at post road. This tree has been pruned of deadwood in the last year and four years before that. It really should come down as it has outgrown its livable space and that is what is causing its continued decline. Unfortunately that is the same story with several other oaks on this block further down the road.

209 carroll needs to be removed and will be by DPW. I think This is the second planted tree we have removed from this location. If we plant again we should document damage.

510 prospect is lifting the sidewalk. It is also growing directly into the wires but is showing signs of decay. It is not a hazard at this time and we can re-assess at the next sidewalk complaint.

107 villa. If we are talking about the tree on Mamaroneck avenue, the entire tree is dead. It is on the list for removal.

Pirates cove island was pruned in entirety back in November.

Cove road at the first bend. This tree is completely deceased and is leaning toward the roadway. This road is a main walkway for kids attending hommocks school. There was discrepancy on ownership but it turns out it is the Village's. It will be going on the takedown list.

131 florence. I would like to give this tree a chance to complete another life cycle before we make any decision on it.

Also, As for Grove st. We were tasked with removing almost 100 yards of material from the river after the flooding. In order to do that we needed to create an access point to be able to work. We removed several dangerous and/or dead trees in order to accommodate equipment in this area. We also replaced a storm sewer line that runs right through the area. These removals were necessary to complete emergency river and flood work. They were not for the cameras.

2024.2.7 Removing Trees for Public Safety

Oh, sorry to hear that but totally understand. Let me know when you may be able to come. We meet first Wednesdays of the month.

I think I responded to your explanation about removing dangerous trees in my previous email. When it's a matter of public safety, there's no question about removing trees.

Heritage Tree Program Updates

2/3/2024

Good morning Beverly. This is great.

- 1. I think the first priority would be to create a program and work to get a list and a plan for the HTs on VOM land. I expect there are a lot of HTs in the VOM.
- 2. I have not seen any decent forms for nomination but will continue to look.
- 3. Oregon seems to have a significant state program and puts up plaques for special trees. Such a plaque program might be of interest to the VOM and residents.
- 4. While the VOM may have control over maintenance of its own trees, I think an HTP within that might be valuable and could be publicized.
- 5. According to a survey I have, the large oak on my property on S Barry is on VOM ROW property. I am concerned about this tree as it is on bedrock and I am not sure how to assess its future. This is the one I wrote you previously had been called a Heritage Oak by the folks that fertilized it years ago it must have been directed by the VOM. Any thoughts you have would be greatly appreciated.
- 6. The concept of a private HT being protected from development, as you write below: I did not mean to suggest that these would alter development and, you are of course right, it would be a mess legally. I meant VOM HTs in the ROW, which may be covered anyway (for example my oak if the MBYC was to run a sewer line up to the junction near your house as had been discussed at one point.

Thank you again Chris! I will be taking these documents and suggestions into tomorrow's meeting. Although some of it is way beyond our current limited status with an HT program, reading about it will be a good beginning for thinking in an organized way.

I think you are right, our first step should be identifying trees on village property, since we can protect and maintain those trees. A contest for nominations is a great idea. Not only will it likely identify many more trees than we currently know about, it will also start people thinking about them and considering trees they know on private property.

Promoting the contest in the schools is probably the most effective way to start. I will see if anyone on the committee would like to design a flyer, including the criteria you set forth (but excluding invasive species such as the Bartlett pear described in the Fabio article) If I get a volunteer may I put him/her in touch with you about it?

So far as I have ever been able to learn — and I've been asking about ROWs for 12 years — each one is unique to each property and the only way to determine it is by looking at the individual deeds. In other words, there's not a global solution.

I usually estimate it as the first 5' from the street but it's only an estimate and of course is affected by how wide or narrow the streets are.

The practical solution may be first to identify trees that may be in the ROW and then check those deeds. Given how large HTs generally are, it's likely that some will be on both public and private land. The village has been pretty good about taking responsibility for those trees, but give the recent changes, I don't know what will happen in those cases going forward. We'll have to anticipate questions.

Actually, we wanted to plant trees in that area several years ago. What we found is that the curb is broken down and too low next to the planting strip (ground between sidewalk and street). The Boston Post Road is a state road and NYS did not ground down the roadbed when they resurfaced. Consequently, parked cars are frequently partly on the strip. Not only would they easily damage new trees, but the ground itself is compacted and possibly contaminated.

That leaves the land on the other side of the sidewalk. It belongs to the school district. We asked for permission to plant trees but the district believes it would create safety concerns.

Attachment 4 Dead Tree at 209 Carroll

Hi James,

I just noticed in my notes that you have responded last month about removing the tree at 209 Carroll.

You commented that this is the second tree removed at this location. I agree with your hesitation about planting another replacement. The tree has been completely encircled by trimmer damage, most likely the reason it died and probably the reason the first one died, too. We should not be planting trees where they will be destroyed by deliberate negligence.

Would it be possible to issue a violation or warning for destruction of Village property? Section 318-5 A (3) of the Tree Law states: "No person, including a person employed by or acting on behalf of a public utility, may injure or destroy any tree on public property."

The tree at the corner of the BPR was not healthy. I had already asked DPW to inspect it as a possible public safety risk. I lost track of my own request (okay I was on vacation), and of their response:

<u>Carroll street at post road.</u> This tree has been pruned of deadwood in the last year and four years before that. It really should come down as it has outgrown its livable space and that is what is causing its continued decline. Unfortunately that is the same story with several other oaks on this block further down the road.

<u>Additional comments today, 3/3/2024:</u>We had another large limb come down in a wind storm so I had the tree removed as there was no canopy left and has rapidly deteriorated.

The Village recently introduced using Structural Soil under new pavements that are near trees, and, in certain cases, as part of sidewalk repair for root interference in an effort to save mature trees.

I hope this fledgling program will continue under the new administration. In the case of the tree at Carroll and BPR, unfortunately, the tree was already failing seriously.

Good morning Natalia,

Thank you for your e-mail.

We appreciate your concerns, specifically the issue with the area located on the northerly side of Bishop Avenue along the Railroad Tracks, which is currently being utilized as a temporary staging/storage area for our sewer rehabilitation contractor. After careful consideration of alternative Village owned properties, it was decided that this location was better suited to the needs of both the Village and the contractor for its centralized location with respect to the rehabilitation work locations scheduled for this year. Furthermore, it is the single location that is not situated either within the floodway and/or flood zone, is not already occupied by a Village

Facility, does not have accessibility issues, has adequate space for the contractor's equipment, and not a public park or paid hourly parking.

We understand the impact this may have to the residents on Bishop Avenue, specifically the visual and tranquility impact concerns you raised, rest assured that every effort will be made to minimize disruptions. To that end, I have instructed the contractor to install shielding/privacy screen on all the fencing facing Bishop Avenue to address the eyesore concerns and have changed the contractors starting start time to 7:30am to assist with minimizing early morning noise levels.

Please note that this will only be a temporary staging area and once the work is completed, will be returned to its former use.

We value your understanding and cooperation during the construction period.



Attachment 12 DRAFT Revised Text for Tree Committee Page

The Tree Committee is an advisory committee with a mission to preserve trees and increase the tree canopy of the Village of Mamaroneck.

Not only are trees beautiful. They also absorb huge amounts of water, helping to prevent flooding. They cool our homes and buildings, provide food and shelter for wildlife and freshen our air by converting carbon dioxide to oxygen.

With these vital benefits in mind, the Village introduced a <u>Tree Law</u> in November 2023 to safeguard both village trees and private trees.

In 2010, the Village began an extensive tree replanting program, and by the Spring of 2017, Mamaroneck had planted 1,000 new trees on Village streets and in public parks. The Village plants 100-120 new trees every year.

The Tree Committee also organizes events and programs—including seasonal tree walks and author talks — to educate residents on the importance of trees.

Attachment 14 Florence Park Renovations

Dear Mayor, Board Members, Dan, Tree Committee, and PRC Members,

I hope this message finds you well. I am writing to provide an update on the progress of the Florence Park redesign project, particularly regarding the playground area and the necessary renovations.

Since last year, we have been diligently working on the design and improvement of Florence Park, with a focus on enhancing the playground area in collaboration with Play Safe. Following the approval of the certified resolution, we have made significant strides, including the ordering of playground equipment and engaging with an approved contractor to commence work on the playground area.

I'm pleased to inform you that the playground equipment is scheduled to arrive on March 18th, 2024, aligning perfectly with our timeline to complete the work before the school's release and the onset of summer. Our target completion date for the entire park renovation is the end of June, strategically minimizing park downtime during peak usage periods.

Regrettably, despite our initial intention to treat this project as one cohesive phase, the unavailability of the finalized site plan necessitates a slight adjustment. Therefore, I propose we approach the project in two phases. We will begin by closing down the playground portion of the park to facilitate the storage of new equipment and prepare for subsequent site work. This phased approach ensures a safe and efficient execution of the project.

One pressing concern in Florence Park is the safety hazard posed by numerous tree roots, which have caused damage to walkways, curbs, and the poured-in rubber surface, resulting in sinkholes. To address this issue, I have been in contact with Beverly from the Tree Committee to identify problematic trees. Currently, there are 17 trees that require removal due to safety concerns. These trees will be replaced with new ones, strategically positioned to mitigate future root-related safety issues.

As part of the playground area renovation, I will oversee the removal of five trees and their stumps to create a safer play environment around the playground equipment. Additionally, I have scheduled a conference call with the playground representative and contractor to finalize details. Once these discussions are concluded, I will determine a closure date for the playground during renovations.

Furthermore, on the day of tree cutting, I plan to temporarily close the Florence Street side of the park to ensure the safety of both residents and working crews utilizing the walking track and school cut-through.

I will promptly share the site plan for the rest of the park with everyone once it is available, enabling us to proceed with the remaining renovations seamlessly.
