## PRESENT:

- 1. Call to Order: 7:35PM
- 2. Approval of March Minutes

## 3. Correspondence:

a. <u>Stuart Ave</u> – Grounds Maintenance at Guion Creek Kate Weingarten request for clean-up of invasive ivy was dealt with by the Parks Dept. She was satisfied with the handling of it.

## 4. Old Business:

- a. <u>305 Fourth Street</u> The tree was found to be healthy and will not be replaced. We will check on the tree annually.
- b. <u>820 Woodbine Ave.</u> Resident requested a tree and it was put on a call list. The tree was planted.
- <u>704 Shore Acre Drive –</u> 5 diseased elms were removed. The area needs to be graded and seeded. Tony said he will address it in the next two weeks.

- d. <u>404 and 407 Creek</u> a pruning request was made for broken and poorly pruned tree.
- e. <u>Palmer Court</u> crooked tree has been corrected but the stakes are still crooked. Picture was provided.
- f. <u>300 Boston Post Road</u> There is a dead tree on BPR near The Toy Box that needs to be removed. Picture was provided.
- g. <u>Harbor Island Park, "HIP" near Firemen's Memorial</u> There is a pear tree growing in an evergreen that needs to be removed. The committee discussed repurposing the wood. Wendy suggested a bench for the playground however wood may not be heavy enough.
- h. <u>Palmer Ave. and Rockland Ave</u>. two dead trees need to be removed. Picture was provided.
- i. <u>325 Prospect Ave.</u> Dead tree needs to be removed. Picture was provided.
- j. <u>Florence Park Tree</u> (With yellow tape). Tree may just need to be pruned. Bev will ask Village Manager to take a look at it.
- k. <u>710 The Parkway</u> Bev will ask Tony to remove small dead tree.
- I. <u>321 and 325 Stanley Ave</u>. Tree and stakes are crooked. Picture was provided.
- m.<u>New Tree Plantings</u> 21 small bareroot trees were delivered and planted. It was suggested to use 4 stakes instead of 2 to prevent leaning.
- n. <u>Water Treatment Plantings Request</u> Dan Sarnoff requested a county map of the underground architecture to ensure appropriate locations for trees. No response yet from George Latimer. Bev will follow up.
- o. <u>Metro-North Tree Replacements along Bishop and Hoyt</u> Still researching resident to help with a petition with community signatures to show their support.

- p. <u>Guided Tree Walk</u> Jason Pinto will be contacted regarding his event. Jocelyn Kleinman of Sheldrake Environmental Center will oversee the walk. Guion Bird Sanctuary was suggested. The dates recommended were May 16<sup>th</sup> and a rain date of May 23<sup>rd</sup> both Sundays at 1PM.
- q. <u>Clean Up/Green Up Day</u> Wendy and Ellen will attend event. They will have a table with maple seeds, dirt and cups to germinate the seeds. Gail to provide instructions to be handed out.
- r. <u>Essential Workers Tribute</u> The space at Rushmore at HIP was picked for this living tribute. White oaks, tupelos and sweet gum were suggested. Plants need to be 32 feet apart. Curved stone benches were suggested.





Hi Dan, I will notify our forces about the graffiti so they can go an inspect it and see how it can be addressed. As far as the parking area along Bishop Avenue that property is not own or controlled by Metro-North.

Please see the attached email to Jerry last fall regarding the area at the base of the wall which provides some background on the trees that were removed.

As mentioned, Metro-North has an ongoing effort where our crews are cutting trees and vegetation throughout our system that have the risk of growing & falling onto overhead catenary and signal wires, as well as toppling onto our tracks. When this occurs during weather events, train service is disrupted for our customers as we cannot operate our trains through the affected area until the trees are cleared and the wire damage is fixed. While we appreciate the issues

raised by your residents, we have no plans or funding to restore the area as this would only recreate the same issue as to why the trees on our property were removed in the first place.

However, we are open to discussions with the Village on a beautification agreement that identifies a certain area of Metro-North property that would then be maintained by the Village. As part of this agreement, we would work with the Village on a plan for this area that would require our input, review & approval in order to proceed. We have concerns with the Village wanting to replant Arborvitae along Bishop Ave as the trees will eventually grow and recreate the issue with impacting our wires and track area. Funding to implement any approved plan would have to come from the Village who would then be required to maintain the defined property.

#### Village of Mamaroneck Arts Council Proposal for Essential Workers' Tribute

Objective: This proposal outlines the plan to install a living tribute to the essential workers of Mamaroneck. A 75' diameter circle of trees with benches and a raised compass center will be a dedication of gratitude as well as a way to beautify and put to use the greenspace on the west side of the harbor.

Location: The Harbor Island Conservancy determined that the tribute will be housed in the West Basin by Mamaroneck Harbor. The map shows the approximate location of the tribute.



Materials:

• eight trees: four tupelo and four white oak standing between 35' and 60' high at maturity, planted as saplings.



• raised metal and granite stand-alone compass measuring approximately 4' in height created by a sculpture artisan to be determined



- four granite benches with an engraved dedication to these groups of essential workers:
  - o Essential Services and Safety: fire, police, EMS, sanitation, and public works
  - Healthcare: doctors, nurses, aides, pharmacists, therapists, hospital and healthcare workers
  - 0

- o Education: teachers, school administrators, and librarians
- Food and Delivery: grocery and supermarket staff, restaurant workers and restaurant delivery drivers, post office staff and post office delivery





There will be four granite benches and perhaps a flat brick circle on which the benches and compass will sit.

The Arts Council and the tree committee believe in a space that serves the public and provides a retreat for thanks, quiet, contemplation, meditation, or rest.
