3. Correspondence:

- a. <u>288 Prospect Ave</u> Large tree, 90 years old, removed at 311 Prospect and will be replaced in a year
- b. 402 Heathcote Two VOM oaks removed
- c. 700 Fenimore -- Tree split and Jerry will inspect it
- d. <u>138 Jensen</u> Sap on car is due to airborne pollen. Jerry Sean will explain to writer, Lisa Axisa.

4. Old Business:

- a. Trees For Maintenance & Removals -- List is being kept up.
- b. <u>Tree Removals</u> HIP near Firemen's Memorial -- Bradford pear growing within the limbs of healthy evergreen. They are not beneficial for each other so the pear was removed.
- c. <u>New Trees</u> HIP cherry trees should be inspected, some need to be replaced.
- d. <u>Westchester County</u> VOM to incorporate new trees into dog park design. Will Jerry will work with county about providing trees on county property by water treatment plant?.
- e. <u>MetroNorth Trees Replacement -</u> Village Manager is working with MetroNorth on plan along Bishop to replace trees that will not interfere with powerlines. The plan will require resident approval.
- f. <u>Tree Inventory Three Rye Neck students have volunteered to conduct the inventory and will receive training and VOM badges.</u> They will also be given pruner vests and Jerry will order them.
- g. <u>Tree Ordinance</u> Developer has cut down 50-60 mature trees at 1010 Orienta Ave. Currently there is no approval process for this. The VOM needs a tree ordinance to protect mature trees. Nora shared the TOM's tree laws.
- h. <u>Guided Tree Walk</u> Fall walk will continue from the Spring walk going along the Parkway. Date scheduled is October 17th at 1PM. Rain date is October 24^{th.} Tree Committee will sponsor. an online talk with Douglas Tallamy on October 14th, author of *The Nature of Oaks: The Rich Ecology of Our Most Essential Native Trees* and *Bringing Nature Home*. Program will be a partnership with Mamaroneck Public Library, which will host the program and also publicize it. Prior to the online talk there will be a book discussion on Wednesday, September 29th, 7:00 pm, led by Beverley Sherrid
- i. <u>Tree Canopy</u> Beverly shared information from Ellen Silver regarding tree canopy. The minimum canopy recommended is 40%. Concerns were raised regarding VOM's shrinking canopy.
- j. <u>Protective Mulch Rings</u> Rings will be placed around the base of trees to see if they will prevent damage from trimmers.
- k. <u>Citizen Pruner</u> Jerry ordered vest for Pruners to read "VOM Citizen Pruner".

Dear Mr. Tavolacci

I am again writing with a complaint about 1010 Orienta Avenue.

As can be seen in the photo below taken on Tuesday, the site is fully active with heavy machinery, a dumpster, a half acre of disturbed earth and a major excavation in the front yard.

Today, in response to my FOIL request below I received a single record, a Parcel History dating back to 1987. I was also informed that there was no Building Permit Application, no SWPPP, no plans submitted and no inspections of the work.

The Parcel History only shows one permit issued in the last fourteen years. On 6/11/21 a permit for "Electrical wiring to relocate existing 100-amp service to existing property pole for temporary power during construction."

However, that does not comport with what the Assistant Building Inspector and Village Manager explained to the Tree Committee.

On June 2 after apparently a lot of trees had already been removed, the Village Manager wrote "They applied for a demo permit for the property. I have copied Dennis and Frank." Is that true, the property owner applied for a demo permit but it wasn't issued.

On June 21 the Assistant Building Inspector wrote a Tree Committee member that "I was just there and they are taking down more trees. They had the property surveyed and are waiting to here (sic) back from DPW about then(sic) right of way to see if the 1 tree next to the driveway is on village property."

This makes no sense to me, if they had had the property surveyed why would they need to check anything with DPW? More importantly, in the three weeks since this came onto the Building Department's radar didn't anyone in your office realize that that NO permits had been issued for work except for the electricity?

If a Stop Work Order has not been issued yet, I believe it should be, the appropriate violations issued for the work performed to date without permits and no permits issued until the property owners have complied with all applicable Village regulations.

The first photo is how I found it, the second is with the bracing removed.


Please consider asking that the Village Manager remove all bracing from Village trees that is more than a year old.



No, the american dogwood blooms earlier and has a somewhat different shape than the kousa. The flowers are the same shape. The really beautiful kousas require a great deal of pruning to achieve the structure that people admire so much.

I haven't heard about a squirrel problem with the crabapples. The variety we plant doesn't drop its fruit, which might help.

You have a few weeks to decide, I am working on the list and right now just need to know where trees are going, large vs. small, and how many.

Do you mean larger than 2" diameter, or taller trees (different species)? To be honest, larger diameter trees don't establish as well, the 2" ones grow more quickly and catch up pretty fast. You need a small species along the street because of the overhead wires. If we also plant something farther back, a taller species might work, I need to look again.

Dear Chairs and Members of the Tree Committee,

I am writing with a few comments prior to your meeting tonight.

Comment 1 - My communication, below, about the decline of the Tompkins Farm Oak, the oldest tree in the Village, is not listed on your agenda.

Comment 2 - Attach. 10 has an email to a resident advising them that "Cornus Florida - American Dogwood" is one of the trees the TC is thinking of planting this year. Please note, Cornus Florida is NOT on the VOM Recommended Tree List https://www.village.mamaroneck.ny.us/sites/g/files/vyhlif826/f/uploads/vom 2011 approved street trees.pdf.

Comment 3 - The BOT took comment last night on the latest version of the Tree Law last night. I made my comments about what I believe is the over reach of the law and a number instances of problematic language. It should also be noted that it appears that the noticing was defective in that it gave a date of October 25th, not last night, for the Public Hearing.

Comment 4 - If the TC members want to make the argument that planting trees would mitigate the Village's riverine flooding issues I hope that future plans for planting trees will include the actual areas devastated by the flooding.

2) Dear Chairs and Members of the Tree Committee,

The oldest known tree in the Village, the Tompkins Farm Oak (TFO), is in sharp decline as can be seen in the photo below. The crown has thinned significantly and there are multiple branches, from the bottom to the top, where terminal end growth has stopped.

This is especially sad for the Tompkins Farm Oak neighborhood which for thirty years led the efforts to protect the tree from damage by developers and the Village.

I hope the Board will advise the BOT to take prudent steps to determine the present condition of the tree and any steps that may prolong it's life.

My suggestion would be that the Village hire a Consulting Arborist to evaluate the TFO.

Please don't let the Village Manager hire Frank Buddingh or Ken Almstead of Almstead Tree.

Mr. Buddingh is not a consulting arborist and is conflicted because he was the arborist the Village hired in 2012 to greenlight the work, against the NYSDEC Forester's recommendations, that likely put the kiss of death on the TFO.

Ken Almstead is a consulting arborist but his company will get paid to do any work on the tree. Also, it was Almstead Tree that was hired by the Village in 2012 to supervise the Pine Street excavation below the TFO and allowed contractor to ignore the preservation plan for the TFO.

Subject: Proposed Tree Law

Wendy,

I compared the latest version with draft 20 from July 2020. As discussed, I agree that the purpose is to get a law on the books, with the understanding that having something now is better than spending more time trying to get a "perfect" law than can be passed.

I'll group my comments into editorial comments (e.g., sentences that aren't clear) and those dealing with more substantive issues. On the latter, we did submit comments (attached for your reference) to the Mayor and Trustees about a year ago. I assume those comments were reviewed by the Tree Committee (can't tell by comparing the two proposed laws).

Editorial/grammatical comments (surprised to find these issues. Perhaps the version was posted before final review.):

- Section §318-7A: In paragraph (1) should the word used be "does" or "do"? If the subject is "branches", I think the work would be "do" not "does".
- Section §318-7A: Paragraph (2) starts as follows: "remove any dangerous tree on the property. Is located must remove the dangerous tree when directed by the Village Manager or the Village Manager's designee." Clearly this is not a sentence and needs to be clarified.

- Section §318-8A: Paragraph (1) has an extraneous comma. End of paragraph (2) has
 the word "either" but nothing to compare it to ("unless he or she is either in the
 possession of a permit to do so issued by the Building Inspector."
- Section §318-8J: Another grammatical issue in the first sentence. It reads "Any trees
 that does not survive..." Should be either "Any tree that does not survive..." or "Any
 trees that do not survive..."

Substantive issues:

- Section §318-8B(2): I addressed this in our comments from a year ago. How is the
 Village Manager going to be choosing certified arborists for this work? Will he publish a
 list? A homeowner might want to know in advance if the arborist he is relying on is
 already approved by the Village for this purpose. It would be awkward if two certified
 arborists come to difference conclusions as to the condition of a tree.
- Section §318-8C: I also addressed this in our comments from a year ago. My specific concern then was if trees previously came down as a result of a storm or had to be removed because they were unhealthy/dangerous. I think replanting should be adequate instead of forbidding additional tree removals for a three-year period.

Please note that these comments are for consideration by the Tree Committee (I don't have the emails for the co-chairs of the Committee – please forward to them). I am not writing them up for the Mayor and Board at this time.

Thank Wendy! This is what I emailed:

Dear Mr. Mayor and fellow Trustees,

We are not happy with the clear cutting done near us. It is a disaster for soil erosion and aesthetics. We support the Tree Law. However we have a couple of minor suggestions which we believe would improve the law by making clear that "permitted use" (which is undefined) should be replaced with "any use that is not prohibited by law," so that the Building Manager is not put in a position of deciding what use should be permitted on private property.

Also, the Tree Law states that the "Building Inspector may grant a permit to remove a protected tree on private property . . .

If the application conforms to the Tree Law, and there is no special need for the exercise of discretion by the Building Inspector, ie, when a single tree is being cut down and replaced pursuant to law, shouldn't the Village be *required* to grant the permit? We would think a lot of problems could be avoided if "shall" replaced "may," at least to avoid interference with a permitted use highly valued by the property owner.

Please be so kind as to share this with your fellow Trustees, and feel free to read it at the meeting if it would be helpful. We are sorry we could not attend personally. We care deeply about clear cutting. It has ruined some lovely properties right around the corner. We also care about not interfering with the enjoyment of the beauty of nature with which a single tree can, occasionally interfere.

There is no tree we are dying to cut down on our property. However we could have neighbors who value their views of the Sound as well, or who would have views if we cut down a single tree. Clarifying the Tree Law would insure that it increased property values and would not have an adverse effect by making permitted uses uncertain and subject to the understanding of a single Village employee, no matter how well intentioned.
