

NOTICE OF PUBLIC HEARING MAYOR OF THE VILLAGE OF MAMARONECK

PURSUANT TO GOVERNOR ANDREW CUOMO'S EXECUTIVE ORDER 202.1, ALL IN-PERSON PUBLIC ACCESS TO VILLAGE OF MAMARONECK PUBLIC HEARINGS IS SUSPENDED. PURSUANT TO EXECUTIVE ORDER 202.15, PUBLIC HEARINGS MAY BE HELD REMOTELY VIA VIDEO CONFERENCE OR OTHER SIMILAR SERVICE.

PLEASE TAKE NOTICE THAT **MAYOR THOMAS MURPHY** WILL HOLD A **PUBLIC HEARING ON WEDNESDAY, MAY 27, 2020 AT 10:00 A.M.** TO DETERMINE WHETHER OR NOT CYNTHIA GREER GOLDSTEIN, A MEMBER OF THE VILLAGE PLANNING BOARD, SHOULD BE REMOVED FOR CAUSE.

ON NOVEMBER 29, 2019 FOLLOWING A HEARING, THE VILLAGE ETHICS BOARD FOUND THAT PLANNING BOARD MEMBER GOLDSTEIN HAD VIOLATED VILLAGE CODE OF ETHICS §§ 21-4(C) AND 21-4(N) RELATED TO CONFLICTS OF INTEREST. THE ETHICS BOARD RECOMMENDED, PURSUANT TO ITS AUTHORITY UNDER VILLAGE CODE OF ETHICS § 21-14, THAT THE MAYOR REMOVE HER FROM SERVICE ON THE PLANNING BOARD. THE DECISION AND RECOMMENDATION OF THE ETHICS BOARD IS AVAILABLE AT [GOLDSTEIN DECISION PUBLIC HEARING URL](#)

NY VILLAGE LAW § 7-718(9) GIVES THE MAYOR AUTHORITY TO REMOVE A PLANNING BOARD MEMBER FOR CAUSE FOLLOWING A PUBLIC HEARING. AT THE PUBLIC HEARING, THE MAYOR WILL CONSIDER WHETHER TO ADOPT THE RECOMMENDATION OF THE VILLAGE ETHICS BOARD THAT PLANNING BOARD MEMBER GOLDSTEIN BE REMOVED FOR VIOLATION OF THE VILLAGE CODE OF ETHICS.
