Dear Mr. Ciotola:

I am writing to submit the Village's fourth quarterly report.

- The Village of Mamaroneck (Village), with the assistance of Malcolm Pirnie/Arcadis, has completed the first phase of the Illicit Discharge Detection and Elimination (IDDE) sampling and investigative plan. A copy of the letter report, which includes the analytical results and recommendations for follow-up investigations, has been submitted to you electronically and in hard copy attached to this letter.
- The sampling of the river and two of the outfalls was completed on August 30, 2012 and August 31, 2012. The remaining ten outfalls were inspected and sampled on October 22, 2012 and October 23, 2012. Samples were collected during dry weather, defined as a 48 hour period with less than 0.1 inches of precipitation.
- The Village met in-house with the Malcolm Pirnie/Arcadis team on Monday, November 19, 2012, to review the maps, analytical results, and report.
- Based on the analytical results of the first round of sampling, the Village and Malcolm Pirnie/Arcadis are recommending a second phase of further investigational work in five of the

drainage basins so that efforts can be made to isolate the sources of illegal direct and indirect connections to the storm drains.

- The formal recommendation is that the Village begin an IDDE program in drainage areas 5, 10, 17, 25, and 26, with priority on drainage area 26. The locations of these drainage areas are shown in Figure 1 in the letter report. The investigation would include additional sampling to confirm these results are replicable, sampling to track and isolate the sources of the illicit discharges, and then techniques such as dye testing, smoke testing, and video inspection to locate the sources so they can be eliminated.
- We would like to discuss this report either in person, or by telephone conference call, sometime in December. I will contact you to determine our mutual availability.
- Our next quarterly report will be submitted by the end of February, 2013.
