Chair Abby Roberts called to order the meeting at 7:33 p.m.

**Old Business**

1. Car Wash Intersection - Ms. Stone stated that the intersection was vary hazardous and recommended that there be a Stop Sign placed west bound on Halstead Avenue and a crosswalk be added. The members discussed the distance between the nearest crosswalks: east bound at Halsted and Ward Avenue, across from the train station, and westbound, at North Barry, many blocks away. Suggested that because of the cars exiting the car wash, Union Avenue might be better for the crosswalk to cross Halstead. Ms. Purdy stated she would make a field trip to the intersection. Ms. Purdy recommended bump out curbs and adding crosswalks and adding another crosswalk on Halstead Avenue. Action for Jerry add to November agenda to discuss.
2. Old White Plains Road – Action for Jerry add to November agenda to discuss.
3. Traffic Safety Issue – Prospect Avenue add to November agenda to discuss.
4. Bishop Avenue – Parking for Residents add to November agenda to discuss.
5. New Signage on Halstead Avenue/Mamaroneck Avenue - Add to November agenda to discuss.

**New Business**

1. Delancey and Cortland Avenue – Stop Sign – Ask Jerry if they could look at that intersection to put a speed sign or another stop sign there and look at the shrubbery. Add to November agenda to discuss.
2. 827/829 Underhill Avenue – No Parking Sign – Jerry to look at the parking spaces to see if they could put no parking signs between the two driveways. Add to November agenda to discuss.

3. Orienta Avenue – Enforcement for the police. Add to November agenda to discuss.

### **Other**

Walking assessment from Abby add to November agenda.

Anne Russo and residents would like to see additional stop signs or a caution sign that could go up at the intersection of Delancey and Cortland Avenue.
