- 2. Mamaroneck Avenue-Pedestrians traffic improvements going towards White plains where the curb is, to make that a median strip Jerry will ask the county to look into it. County discussed looks like we are slated to receive \$100,000 grant. Per. Jerry meeting to be setup with Kevin Rosman for October. Dan reported that we did get funding for phase one. - 9. W. Boston Post Road Traffic Mirror Resident Kelly Susa emailed asking if a mirror can be installed on a pole on the northbound side of BPR, near Burke.
