**Chair Abby Roberts called to order the meeting at 7:34 p.m.**

**Old Business:**

- 1. Villa Avenue** – The members discussed whether this intersection should be reviewed by the traffic consultant. Mr. Barberio mentioned the cost of review by the consultant. Ms. Stone suggested that intersection's safety could be improved by cutting back the bushes on the corner and hatching on Mamaroneck Avenue painting lines to indicate no parking or Standing on Mamaroneck Avenue at this intersection. No U turn intersection Mamaroneck Avenue near Villa north bound side. Motion passed. (Action for Jerry) Put on September agenda.
- 2. Car Wash Intersection** - Ms. Stone stated that the intersection was vary hazardous and recommended that there be a Stop Sign placed west bound on Halstead Avenue and a crosswalk be added. The members discussed the distance between the nearest crosswalks: east bound at Halsted and Ward Avenue, across from the train station, and westbound, at North Barry, many blocks away. Suggested that because of the cars exiting the car wash, Union Avenue might be better for the crosswalk to cross Halstead. Ms. Purdy stated she would make a field trip to the intersection. Ms Purdy recommended bump out curbs and adding crosswalks and adding another crosswalk on Halstead Avenue. Put on September agenda. (Action for Jerry)
- 3. Parking on Seney Avenue** – (Action for Jerry)

4. **Traffic Safety Issues on/near Prospect Avenue** (Action for Jerry)
5. **Bishop Avenue** (Action for Jerry)
6. **Standish Place – Mirror on the pole on Harrison Avenue Motion passed** (Action for Jerry)
7. **\*URGENT\* Union and Tompkins Avenue** – Village to take a look into Pedestrian crossing relocate and paint. Ask Jerry to look at Intersection at Union and Tompkins for safety coming down from Tompkins people cannot see cars coming out of Union and making left turns onto Union and going up on Tompkins. Motion passed
