Chairman Tannenbaum called to order the meeting at 7:30 p.m.

Old Business

Beach Avenue and Tompkins Avenue – 4-Way Stop Sign

Mr. Tannenbaum stated that the intersection of Beach and Tompkins Avenues is now part of the Traffic Study. Signs were newly installed. The Traffic Engineer will make a determination shortly on a speed bump that was suggested to slow down traffic.

Mr. Keck stated that the Association should put lights on the side of the building. A street light was put on the existing corner pole on Beach and Tompkins Avenues.

Mr. Mazzullo remarked that because of the design of Tompkins and Beach Avenues at Boston Post Road and the existing stop sign, the sign was not properly installed and should be twisted approximately six inches to be perpendicular to traffic for better visibility.

R Permits

Mr. Tannenbaum stated that additional streets were added to the R permits list that will be sent to NY State. He said that the Board of Trustees has agreed that 7 am to 7 pm will be the permit times. Temporary R permits for workers and visitors coming to the Village is not yet finalized.

Ralph's Italian Ices

Mr. Tannenbaum stated that there is no resolution just yet. Also, the lines have not been changed in the parking lot. Mr. Tannenbaum stated that the Traffic Commission is eager and ready to assist with traffic issues on this matter.

Mr. Figliomeni said that Ralph's is now open for business for the season.

New Business

Street Cleaning

Mr. Tannenbaum stated that Village street cleaning should be done twice monthly rather than once monthly. Additional personnel would have to be hired and additional equipment made available. Put on May agenda.

Other

Keeler Avenue – traffic light

Mr. Tannenbaum said that there was opposition by residents for a traffic light on Keeler Avenue and the Post Road which is a State road. That traffic light is now by Rye Country Day School.
