- <u>4 at 1000 W. Boston Post Road athletic field</u> — I agree, trees won't survive there. I have relocated them and updated the list to: I'll mark these today.

524 Waverly back lot tree pit near Ogden " acer buergerianum" Need another location.

- 1 at 138 W. Boston Post Rd

we think a like, you have already marked a fifth tree on the HIP entrance, I hope #3 tree i "liquidambar styraciflua", which was at 138. Yes this tree went to HI.

- <u>1 at 416 Waverly</u>, I think you mean 426 Waverly. Personally I think a second tree should be replaced but ok, we can wait and see how it recovers next year. That leaves me with one more crabapple to place. This tree needs to be replaced by the property owner, as per the planning board resolution, the property owners need to maintain the trees and grass area.

- <u>1 at 524 Waverly</u>. I disagree with you here and think that a tree needs to go in the long space near the Drain cover. I marked the street about 5' away from the drain, is that far enough? Same As 426 Waverly. This tree needs to be replaced by the property owner, as per the planning board resolution, the property owners need to maintain the trees and grass area.

- switch on Stanley is fine, sometimes I forget to look up. Thanks. No problem

Regarding <u>524 Jefferson Ave</u>, after you looked at the property, the owner has removed the weeping cherry in the ROW and there is now room to put two small trees 20' apart in his ROW. This is very good because, as you may remember, we have had trouble getting residents to agree to street trees on Jefferson and the road really needs more of them. Will mark them today

I think all I still need to do is place one more crab apple, draw some maps, and meet with you about changing the locations of two of the trees in Shore Acres to accommodate the residents' requests — all within the ROW, Is there a time on Tuesday or Wednesday when you could give me a few minutes?

I will give you the final final list this week.

Beverly,

I'm not sure when the plantings will be done but I need at least a week to check and mark the locations. Then the residents will get notified and within a couple of weeks we get calls about relocating and residents who don't want trees. At that time we need to find new locations where the trees are wanted. This way when the contractor starts to plant they are not held up waiting for us to come up with another spot to plant, it just makes the process go much smoother. That's why we try not to wait to the last minute to mark everything out.

The locations where I could not put a tree are, 4 at W. Boston Post Rd. Athletic Field, and 1 At 138 W. Boston Post Rd., 1 at 416 Waverly Ave., and 1 at 524 Waverly Ave., 1 at 308 Stanley Ave. that tree was switched with the tree at 312 Stanley because 312 had wires above and originally had a large tree going there so I switched it with 308 Stanley.
