LOCAL LAW 1-2017

A LOCAL LAW TO AMEND CHAPTER 285, SIDEWALK CAFES TO REVISE THE DATE IN THE PENALTY PROVISION BY WHICH SIDEWALK CAFES MUST BE REMOVED TO COINCIDE WITH THE PERMITTED DATES.

BE IT ENACTED by the Board of Trustees of the Village of Mamaroneck as follows:

Section I. §285-8.C. is amended to read as follows:

C. Any person who fails to remove a sidewalk cafe by Thanksgiving Day may not be eligible for a license the following year.

Section II. Severability

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section III. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
