Section I. Section 72-1 "Membership" is hereby amended to read as follows:

Chapter 72. TRAFFIC COMMISSION

§ 72-1. Membership.

The Board of Traffic Commissioners shall consist of nine total members, including seven (7) community members, and two ex-officio members of the Commission from the Mamaroneck Fire Department and the Mamaroneck Police Department. The ex-officio members shall include the Chief of the Mamaroneck Fire Department or his designee and the Chief of the Mamaroneck Police Department or his designee. The seven (7) other persons shall be appointed by the Board of Trustees, at least three (3) of whom shall have a background of experience in engineering, systems analysis or general business experience.

Section II. Section 72-2 "Terms; officers" is amended to read as follows:

§ 72-2. Terms; officers.

A. Each of the community members of the Board of Traffic Commissioners shall be authorized to serve at the pleasure of the Board of Trustees for a period of not more than three (3) years.

B. The Chairman of said Board shall be appointed by the Board of Trustees of the Village of Mamaroneck.

C. Each of the ex-officio appointees or designees of the Chiefs of the Mamaroneck Fire Department and Police Department shall be authorized to serve a term not to exceed one (1) year, with no limit on the number of terms such ex-officio members may serve.

Section III. Severability

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section IV. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.




