

Local Law 11-2016

To amend Chapter 326 entitled Vehicles & Traffic to change parking meter fees and extend the hours that meters are in effect in Meter Zone 9 (Mamaroneck Avenue & East prospect Avenue)

BE IT ENACTED by the Board of Trustees of the Village of Mamaroneck as follows:

SECTION 1. The provisions of Chapter 326-54(N) – Fees is amended to read as follows:

- N. A fee of \$0.25 for 20 minutes, or any fraction thereof, for a maximum of two hours, is hereby established for parking in Metered Parking Zones 9, 12, 13, 14, 15, 16(a), (16)b and 17.

SECTION 2. A New Chapter 326-54(Q) – Fees is added as follows:

- Q. A fee of \$0.25 for 15 minutes, or any fraction thereof, for a maximum of two hours, is hereby established for parking in Metered Parking Zones 9.

SECTION 3. The provisions of Chapter 326-55(B) – Payment of fees required certain hours is amended to read as follows:

- B. The payment of fees hereinbefore specified shall be required in Metered Parking Zones 5, 6, 7, 8, 9, 10(a), 10(b), 10(c), 10(d), 10(e), 11, 12, 13, 14, 15, 16(a), 16(b), 17, 19, 20, 21, 22, 23(a), 23(b) and 23(c) during the period from 8:00 a.m. to 6:00 p.m. every day, excluding Sundays and all holidays as designated by the Village Manager.

SECTION 4. A New Chapter 326-55(D) – Payment of fees required certain hours is added as follows:

- D. The payment of fees hereinbefore specified shall be required in Metered Parking Zones 9 during the period from 8:00 a.m. to 8:00 p.m. every day, excluding Sundays and all holidays as designated by the Village Manager.

SECTION 5. Severability.

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

SECTION 6. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
