LOCAL LAW 12 of 2016

A LOCAL LAW TO ADD PROVISIONS REGARDING APPOINTMENT OF VILLAGE PROSECUTOR TO THE CODE OF THE VILLAGE OF MAMARONECK

BE IT ENACTED by the Board of Trustees of the Village of Mamaroneck as follows:

Section 1. The Code of the Village of Mamaroneck is hereby amended by adding a new Article III entitled Appointments to Chapter 9, Board of Trustees, to read as follows:

ARTICLE III: APPOINTMENTS BY BOARD OF TRUSTEES

§9-5. Appointment of Village Prosecutor

The Village Prosecutor shall be appointed by the Board of Trustees. Such appointment shall be for a term of one year and shall be made annually at the Board's annual organizational meeting. Any vacancy shall be filled by the Board of Trustees and such appointee shall serve until the next annual organizational meeting.

Section 2. Severability

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section 3. Effective Date

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
