## **LOCAL LAW 15-2017**

A Local Law to amend Chapter 48 of the Code of the Village of Mamaroneck (Officers and Employees) regarding the removal of members for failure to attend.

BE IT ENACTED by the Board of Trustees of the Village of Mamaroneck as follows:

#### Section 1.

Section 48-2 of the Code of the Village of Mamaroneck, is amended as follows:

§ 48-2. Removal from office due to absence.

The chair of each boards, commissions, councils and committees of the Village of Mamaroneck shall report to the Village Manager whenever any member of the board, commission, council or committee fails to attend three meetings in the prior 12 months or 3 consecutive meeting. If the Village Manager concludes, after consulting with the chair and the member who has been absent, that it is unlikely that the member's attendance will improve, the Village Manager shall remove the member from office. The Village Manager shall report any such removal to the Board of Trustees at its next meeting.

#### Section 2.

If any section, subsection, clause, phrase or other portion of this local law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, the portion of the law declared to be invalid will be deemed a separate, distinct and independent portion and the declaration will not affect the validity of the remaining portions hereof, which will continue in full force and effect.

## Section 3.

This law is adopted pursuant to the authority granted by Municipal Home Rule Law § 10(1)(e)(3) and will supersede the provisions of the Village Law to the extent that they are inconsistent with this local law.

#### Section 4.

This local law will take effect immediately upon its filing in the office of the Secretary of State in accordance with Municipal Home Rule Law § 27.
