A local law to amend Chapter 326 of the Village Code of the Village of Mamaroneck to amend the Residential On-Street Parking Permit System within the Village by adding Jefferson Avenue, from Jefferson Ave. Ext. to Cedar Street

Be it enacted by the Board of Trustees of the Village of Mamaroneck as follows:

Section One. The following amendment is made to Article IX, Chapter 326-98 Definitions of the Village Code of the Village of Mamaroneck as follows:

§ 326-98. Definitions.

As used in this article, the following terms shall have the meanings indicated, unless the context clearly requires otherwise:
