IT IS HEREBY STIPULATED AND AGREED, by and between counsel for all of the parties to the proceedings consolidated under the above caption and index number as follows:

WHEREAS, all of the parties to these consolidated proceedings wish to provide for a reasonable opportunity to reach a mutually satisfactory settlement of all outstanding matters, if at all possible.

NOW therefore:

- 1. All stays in all the consolidated proceedings previously so ordered by this Court are continued until October 15, 2012. Counsel for all parties are directed to appear for a conference with the Court at 2:30 P.M. on that date.
- 2. Respondents John Winter ("Winter") and Lloyd T. Wright ("Wright") and the Mamaroneck Beach & Yacht Club, LLC, Mamaroneck Beach & Yacht Club, Inc. and Taylor Point Associates, Inc. (collectively, the "MBYC Parties") hereby withdraw, without prejudice to their renewal as set forth below, their pending motions to dismiss the consolidated proceedings against Winter (Index No. 11000/2011) and Wright (Index No 12540/2011).
- 3. On or before October 1, 2012, the Shore Acres Property Owners Association and Bennett and Cynthia Golub (collectively, the "SAPOA/Golub Parties") and the MBYC Parties shall notify counsel for Winter and Wright in writing whether they have reached a settlement of their differences, subject to any required approvals from Village of Mamaroneck, other governmental bodies or the court. In the event that counsel for Winter and Wright does not receive written notice of such a settlement on or before October 1, 2012, Winter, Wright and the MBYC Parties shall be entitled to renew their motions to dismiss by notice of motion, upon 8 days or more notice to the remaining parties, along with a copy of this Stipulation.
- 4. In the event of any such renewal of such motions, (a) the pleadings, briefs, affidavits, affirmations and other submissions heretofore submitted to the court by the parties to such proceedings (including the items listed in Schedule A hereto) shall be deemed resubmitted for such consideration as the Court shall deem appropriate; (b) recent correspondence listed in

Schedule B that has heretofore been submitted to the Court in response to its request for information concerning other agency actions need not be resubmitted (however, Winter, Wright and the MBYC Parties believe such correspondence is not relevant to such proceedings, is not part of the record thereof and should not be considered by the Court in determining the motions, while the SAPOA/Golub Parties believe it is relevant to such proceedings); (c) no further pleadings, briefs or legal argument in the form of affirmations or affidavits shall be submitted on such motions unless authorized by the Court; and (d) all parties agree to waive any and all objections to such motions which might arise by virtue of the foregoing withdrawal of such motions pursuant to this Stipulation.
